Hi Randy,

Thank you for inquiring about the status of the Demolition Permit #2016-02810. As you noted, per City Code 6-23, demolition permits expire 30 days after the date of issuance. This permit was issued on 11/29/16 and you informed our office that the demolition is slated to start on 4/10/17 and be completed no later than 4/14/17. In lieu of re-applying for this work, this email confirms that the permit remains in good standing and the demolition can commence on these dates.

Please contact our office to schedule a final inspection for this permit to confirm completion and acceptance of the building demolition and close out the permit.
