Dear Ms. Schmuckal:

I am requesting a permit to allow me the use of my residence for a home occupation. I intend to serve as a massage therapist, helping individual clients gain relief from muscular and other soft tissue disfunction. I believe my work would fall under the category of therapists and health care practitioners - an acceptable home occupation listed under item 2 of Section 14-410 of the Portland code. The following is an explanation of how my home occupation meets the criteria listed under item 1 of the same:

- a.) My home occupation will occupy approximately 114 square feet(12%) of floor area of the first floor of my residence. This is 7.4% of the living space of the entire residence.
- b.) There will be no outside storage of goods and materials and there shall be no exterior displays or displays of goods visible from outside.
- c.) Storage of the materials needed for my occupation are minimal and shall be included in the 114 square feet mentioned above.
- d.) There will be no external sighn related to my home occupation.
- e.) No exterior alterations to the residence are necessary.
- f.) I see one client at a time and have ample parking space in my driveway for a clients vehicle.
- g.) No objectionable effects are generated by my home occupation.
- h.) I will not require the services of any employees.
- i.) There will be no significant increase in traffic due to my home occupation.
- j.) No motor vehicles exceeding a gross weight of 6000 lbs. shall be stored on the property in connection with my home occupation.

My home occupation is a secondary use of my residence. The external effect on the neighborhood is negligable and in keeping with its residential character.

Attached you will find a copy of a floor plan showing the dimensions of the home occupation space. Thank you for your assistance.
