
Dear Ms. Daley:

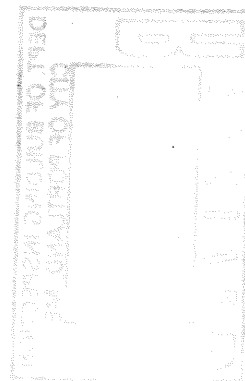

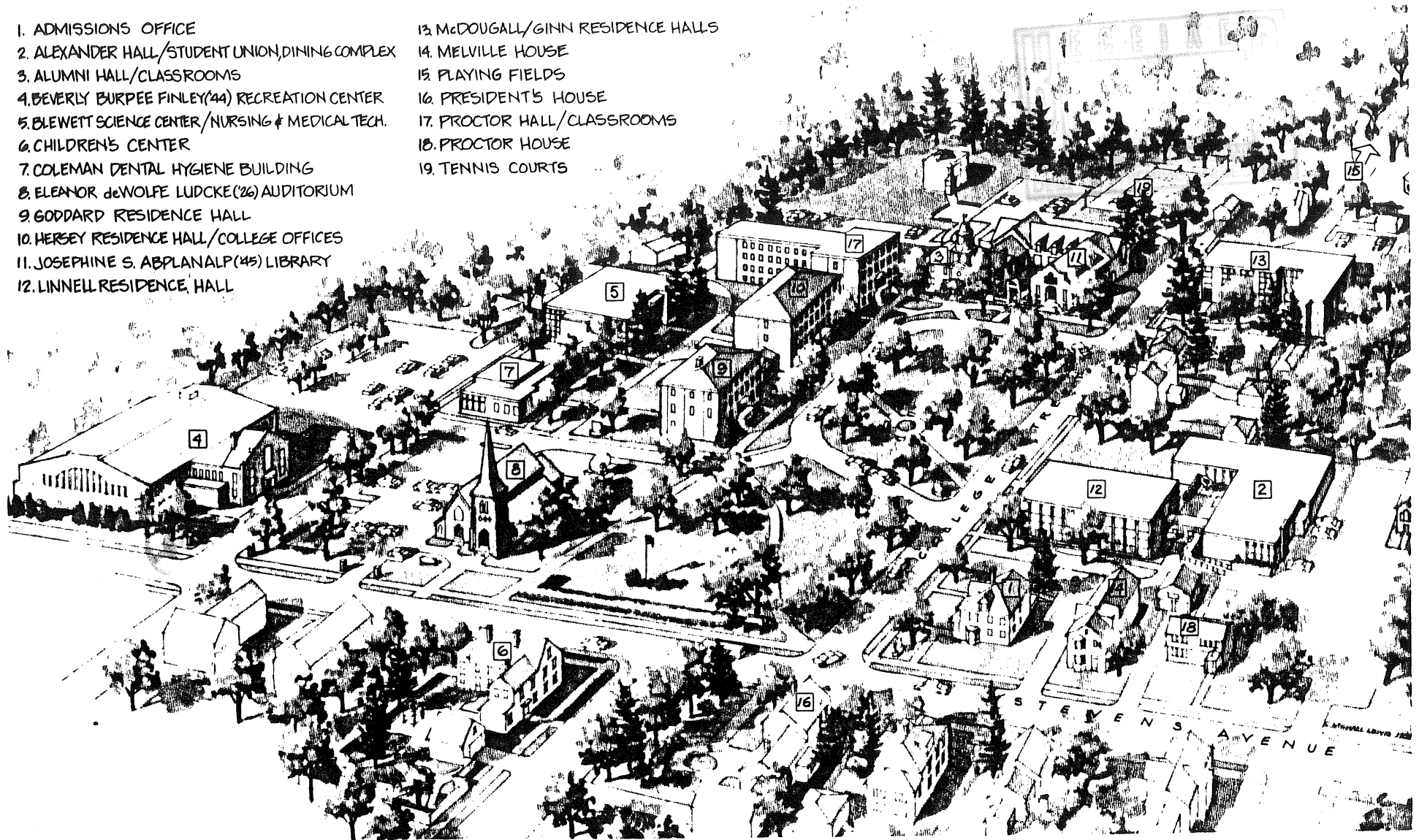
