15.4 <u>Firestopping</u>

There are a number of areas throughout the building where top of wall firestopping and/or partition penetrations have not been firestopped and subsequent work has been installed that will make firestopping difficult. All tops of rated wall and penetrations thru rated walls must be completely firestopped per their respective UL designs prior to start of ceiling construction. Reference Page P6 of 9 for examples.

The horizontal rated drywall that was installed above door entrance 1111 needs to have it's joints and penetrations completely firestopped (no gaps). See Photos on page P9 of 9.

15.5 Spray Fireproofing

Touch up areas of spray fireproofing where it has been removed by installation of subsequent work prior to closing up the ceilings. Reference Photo B page P8 of 9.

All areas of roof deck and structure around the elevator shaft B shall be fully spray-fireproofed. Reference Photo A page P8 of 9.
