Dear Sir or Madam,

VSH Realty Inc. would like to amend the permit application that is currently being processed by the City of Portland Permitting and Inspections Department for the Cumberland Farms located at 1132 Forest Ave. to include replacement of the existing fuel canopy.

The current permit application is for removal and replacement of the fuel system as required by MDEP. During the course of preparing for the upcoming project we asked a structural engineer to examine the existing canopy since we will be excavating near the canopy foundations to replace the fuel lines. The engineer found the canopy to be at the end of its service life and recommended that it be replaced.

We propose to replace the existing fuel canopy like for like. The canopy will be the same size (24' x 24'), the same height, 14'6" to the bottom of the deck with a 3' high fascia, and will have the same signage at the existing canopy. In order to achieve this the existing canopy, including foundations, will be removed and the new canopy will be put up in its place.

We have attached drawings stamped by a licensed Maine Professional Engineer. The site plan we submitted with the original permit application shows the position of the existing canopy. The replacement canopy will be located in the exact same position.

The construction cost associated with this work is:

• Canopy foundations	\$ 15,969.00
• Canopy fabrication and erecting	\$ 17,900.00
