# Non-Water Based Fire Suppression System Permit Application

A permit is required for non-water based fire suppression systems. Full-sized plans and details in PDF format and this application form shall be submitted to <a href="mailto:permitting@portlandmaine.gov">permitting@portlandmaine.gov</a>. Prior to acceptance of any fire protection system, a complete commissioning and acceptance test must be coordinated with all fire system contractors and the Fire Department, and proper documentation of such test(s) provided. All installations must comply with NFPA and the Fire Department Technical Standards.
