• H.E. Callahan completed the installation of the fascia plywood & the plywood for the soffit across the front of the building.						
• Removed the precut plywood on the interior of the building and stacked it to be ready for painting.						
Installed the unfaced insulation in the section of wall between the overhead doors						
• SMR completed the installation of the roof insulation & membrane.						
• Completed the installation of all siding panels & worked on trim.						
• Overhead Door Co. removed the upper portion of track, the operators & torsion springs from all overhead doors but one.						
• Allaire Drywalling hung the 2 layers of drywall over the surface of the existing siding panel to						
develop the fire rated wall.Framed both the north and south end walls with steel studs.

Work Planned for Next Week:

- Install plywood wrapping the header of the existing overhead doors & on interior end walls.
- Complete the installation of roof & siding trim.
- Paint all interior plywood & door bucks.
- Remove paving laid on Monday 11/7/11. Cut back to center line of pier & along the previous cut line to a depth of 1 ¹/₂" & resurface with new wearing course.
- Paint all required lines for parking spaces.
- Resurface the concrete piers.
- Install the new Fire sprinkler system into the new bays.
- Install remaining angles clips at existing columns.

Problems/Issues:

- Due to the lack of materials available the paving crew was not able to complete the paving repair for this project all in one day. They left approximately half of a bay plus the area around the southern end of the addition without a wearing surface. SECS stated that the top wearing course needed to be saw cut back to the centerline of the next pier and that the wearing course in that area was to be removed to make sure that the proper thickness was provided. The paving company however completed the repair without notifying H.E. Callahan and the project supervisor was not on site to oversee the repair and the requirements were not met. Dave LePage of H.E. Callahan is dealing with this issue.
- The Overhead Door Company made a mistake upon ordering the new overhead doors and the new delivery date is tentatively set for December 1st. This will delay the completion of the project.
