BASEBALL FIELD BACKSTOP EXEMPTION

Enclosed is an Application for Exemption From Site Plan Review form for the Baseball Backstop extension at Cheverus High School, on Ocean Avenue. The High School is making the following improvements to their baseball field on the southerly side of the campus:

- 1. Extension of the existing 16' high backstop, with overhang, 20' long toward the firstbase dugout. This extension is intended to decrease the probability of baseballs leaving Cheverus property.
