Conditions:				
1) Structures in the shoreland zone must be set back at least 75 feet from the Highest Annual Tide (HAT) line. The HAT line must be clearly identified prior to pouring concrete and compliance with the required setback must be established. The inspector may require the HAT to be identified on the ground by a surveyor. 2) This property shall remain a single family dwelling. Any change of use shall require a separate permit application for review and approval. 3) This is being issued with the understanding that as a fast track, the owner is responsible for scheduling inspections for the work being done and the inspector may require modifications to the work that has been completed if it does not meet code. 4) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. 5) This permit is being approved on the basis of plans submitted. Any deviations shall require a separate approval before starting that work.
