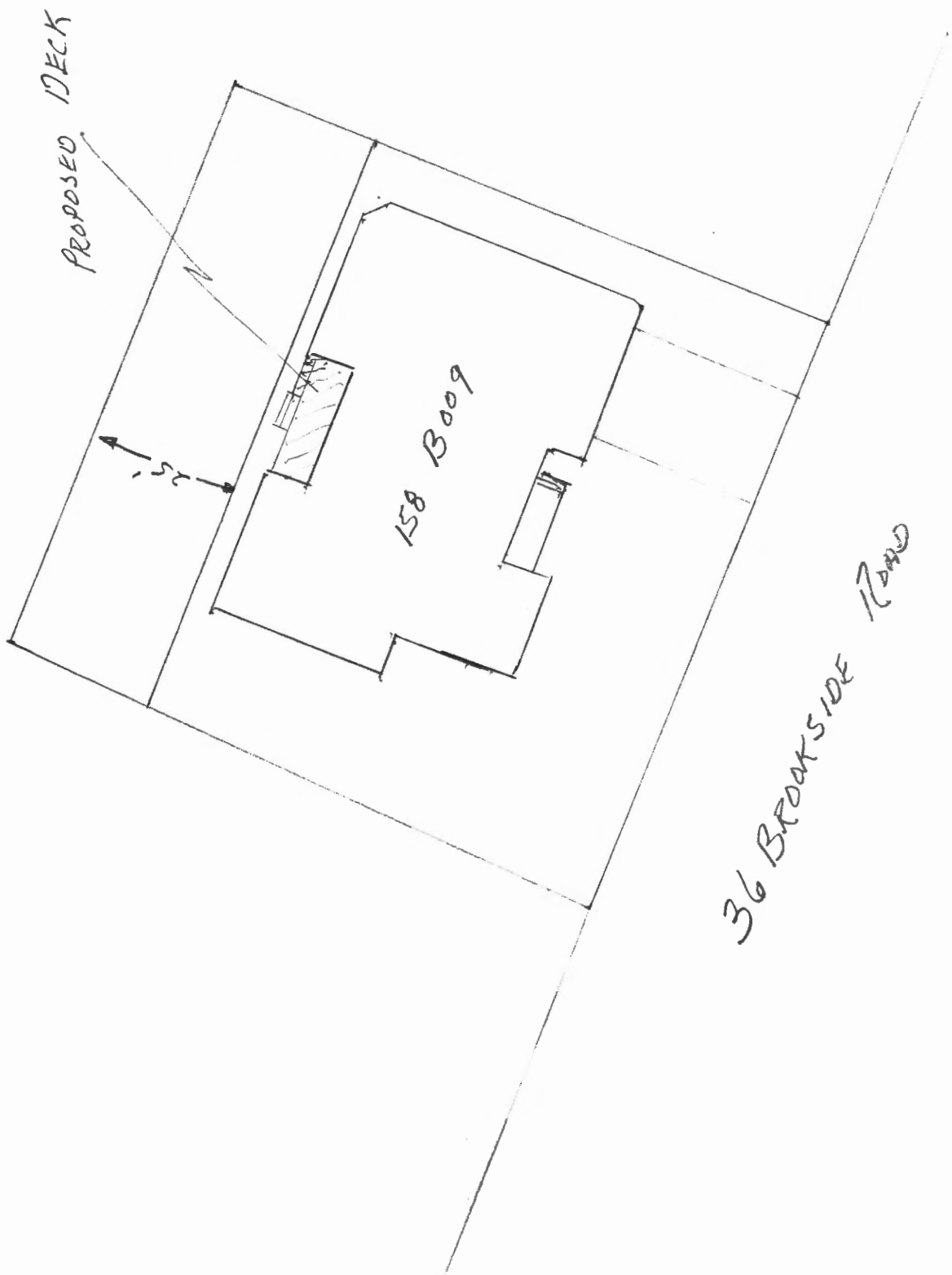

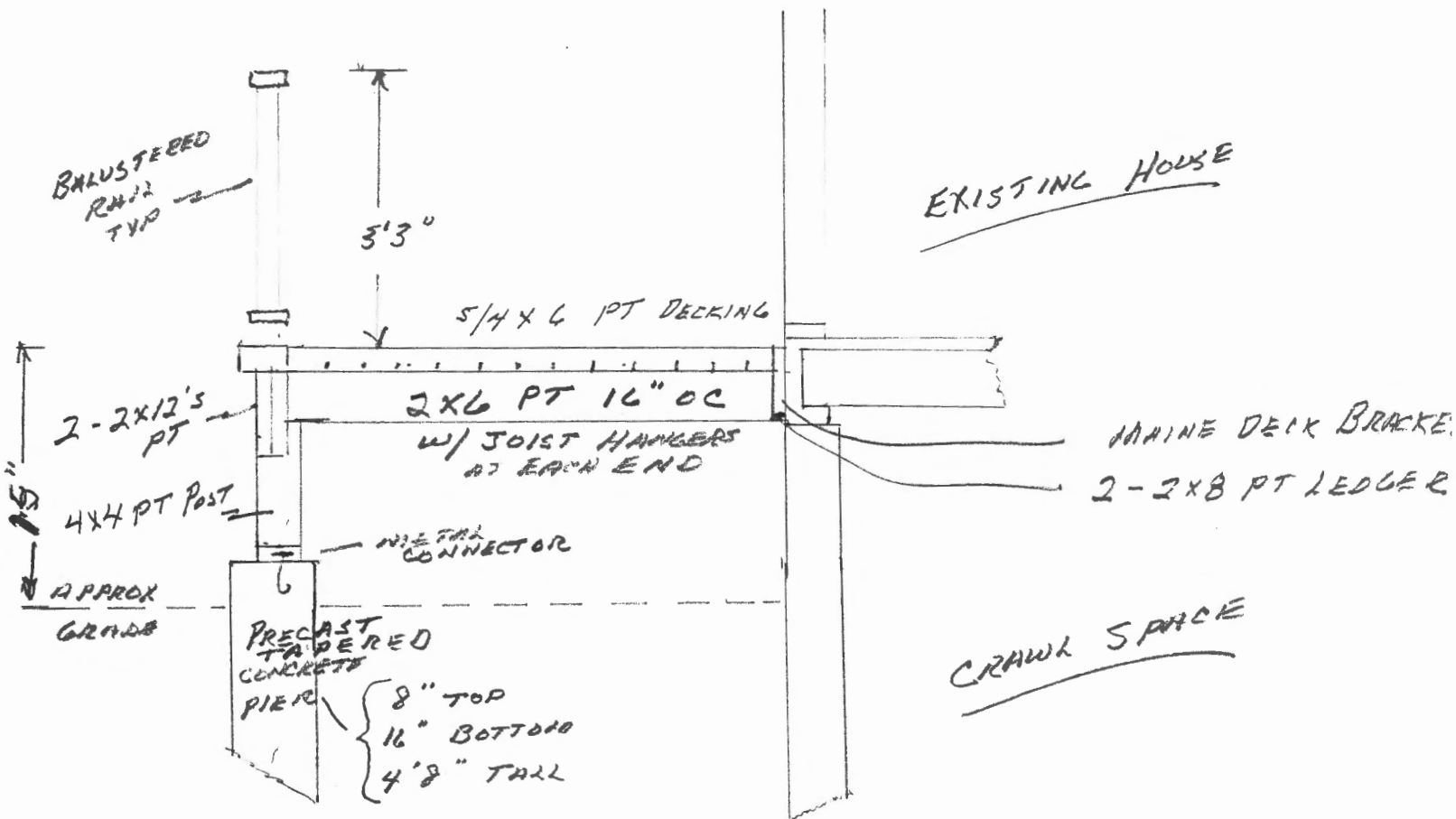

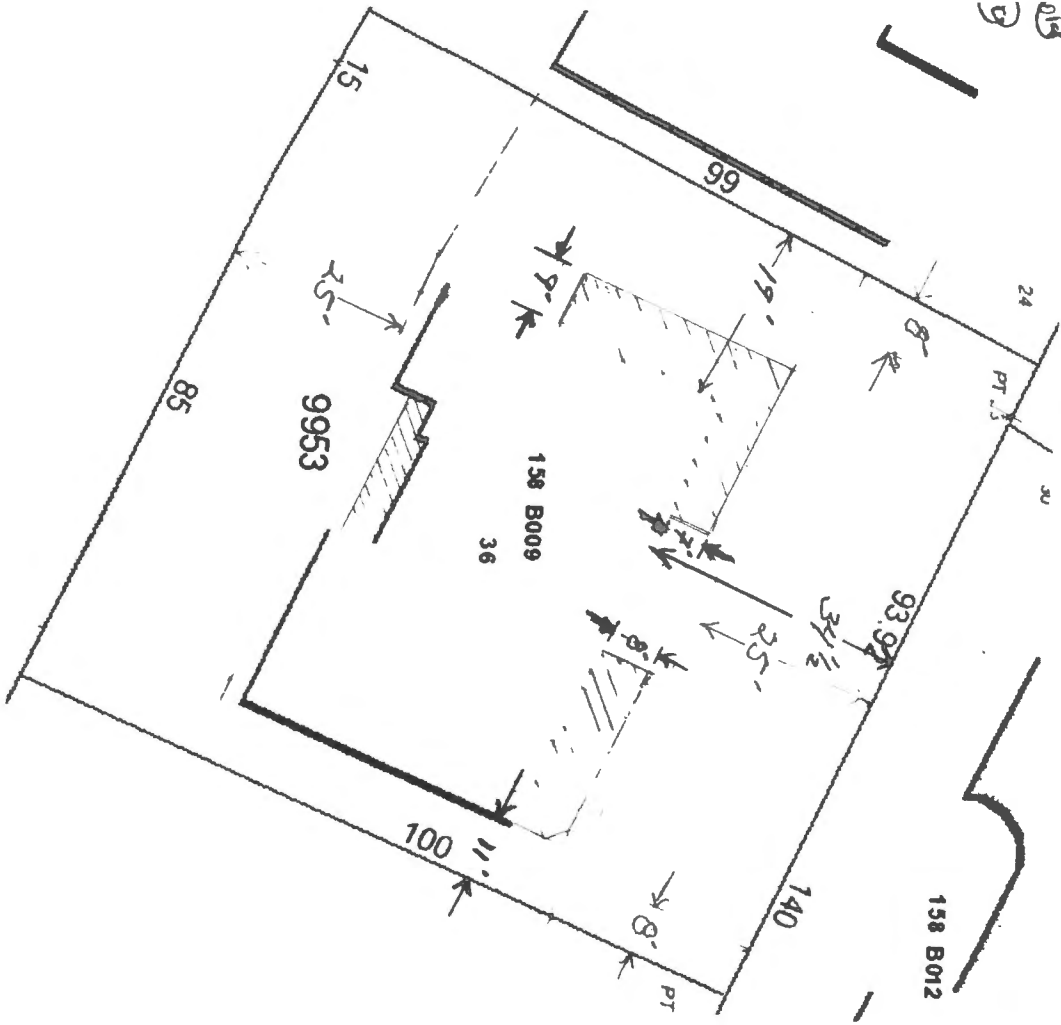


PROPOSED DECK

TOP OF DECK TO GRADE = 15"



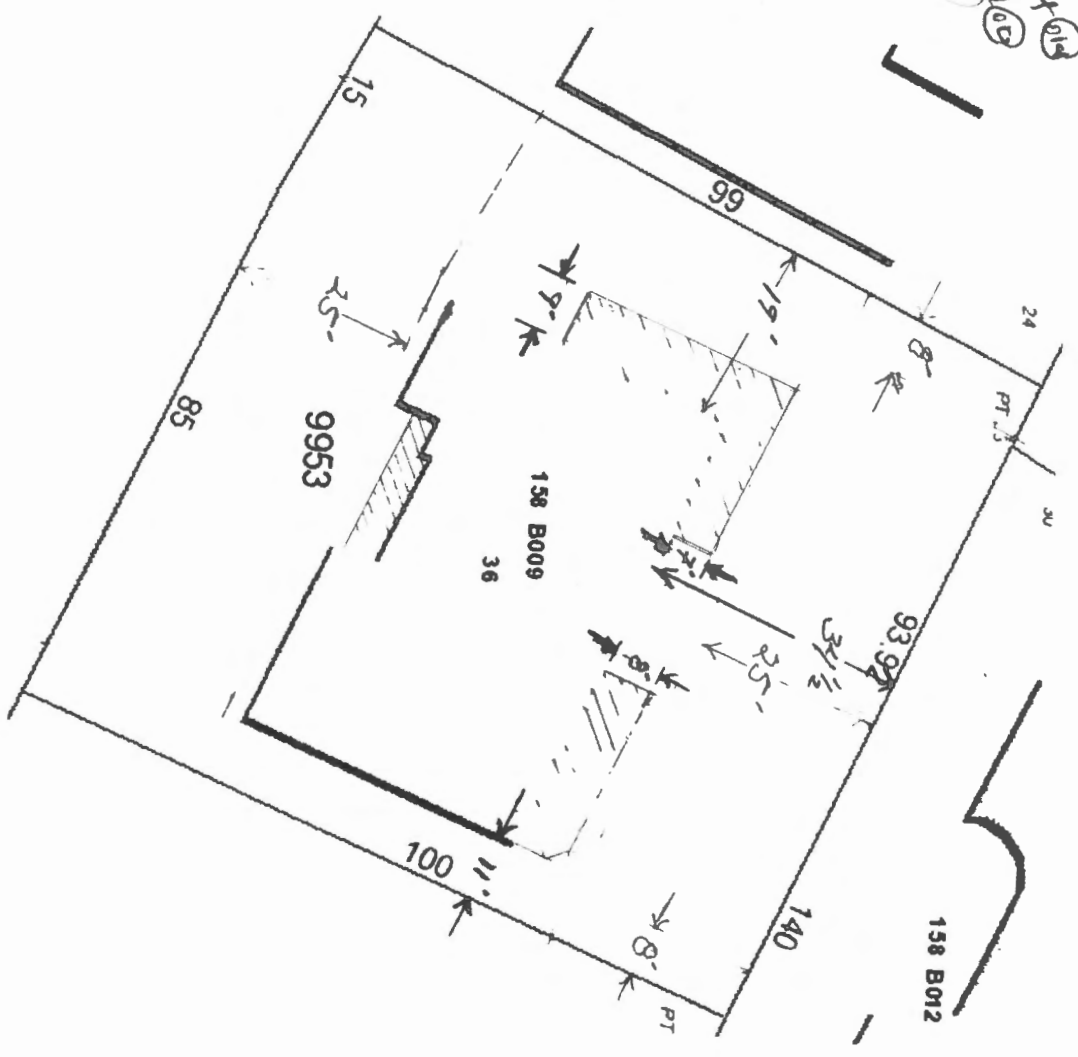
