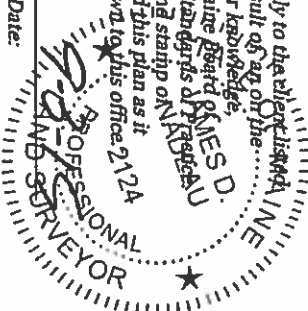

12. Kineo Street adjacent to the Locus Parcel was accepted by order of City Council, passed February 15, 1943, as 50' wide per City of Portland Records Vol. 65, Page 315.
13. All building corner offsets to boundary lines are from cornerboards and not building foundation, unless noted.
14. The westerly and easterly abutting dwellings were surveyed for purposes of determining the average front yard calculations. Per City of Portland Zoning, a front yard need not exceed the average depth of front yards on either side of the lot.

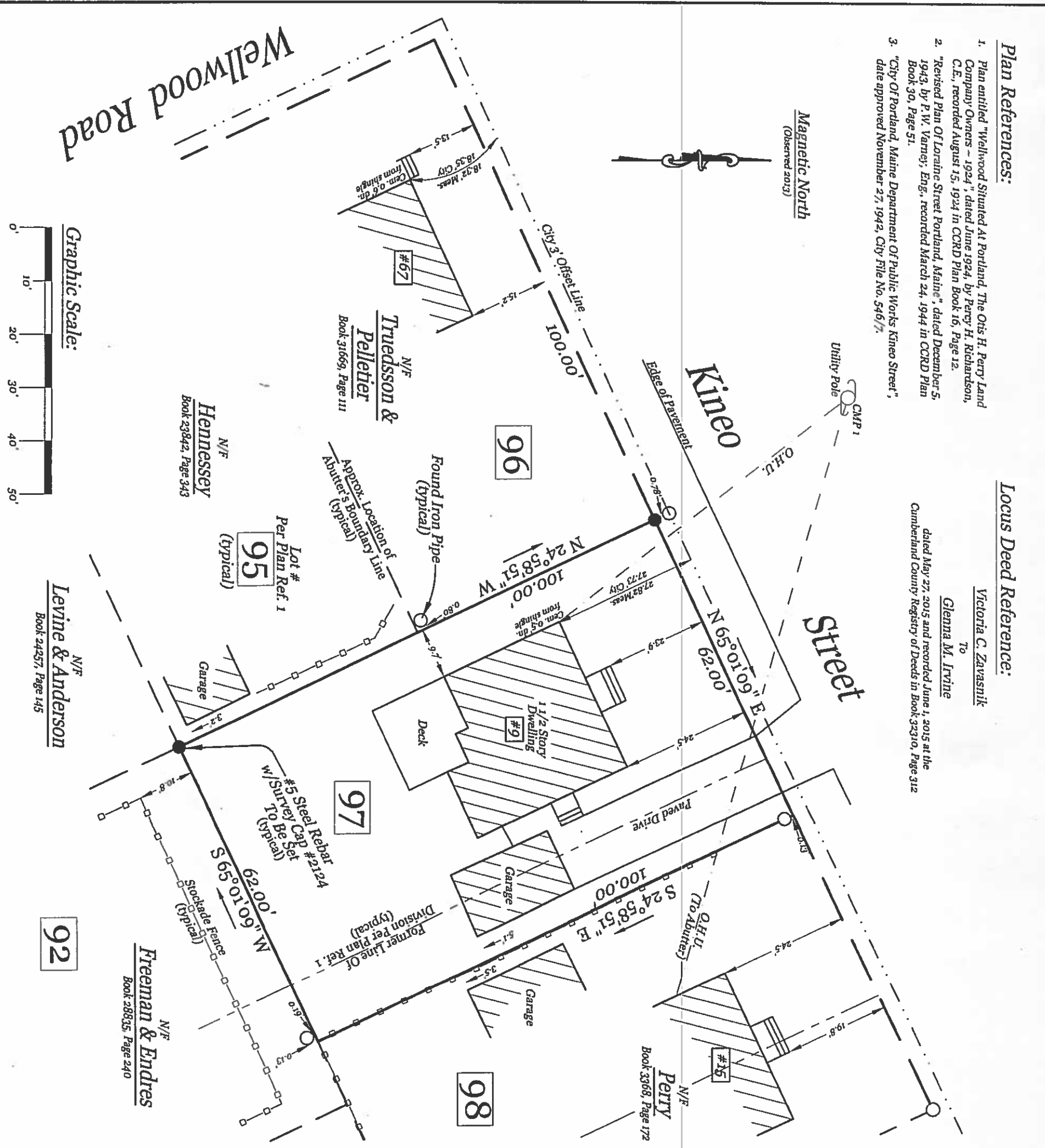

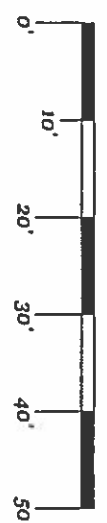
