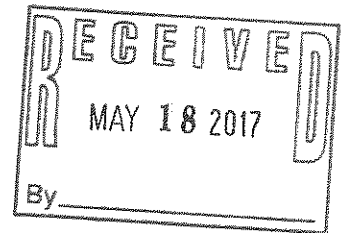

**NOTICE OF VIOLATION AND ORDER TO CORRECT**

<b>NFPA 101- 7.2.1.8.1 FIRE DOOR(S) MUST SELF-CLOSE;</b> A door leaf normally required to be kept closed shall not be secured in the open position at any time and shall be self-closing or automatic-closing in accordance with 7.2.1.8.2, unless otherwise permitted by 7.2.1.8.3. Door closer for laundry room fire door on first floor missing	
<b>NPFA 101- 7.2.2.1.1 STAIRS REQUIRE REPAIR;</b> Stairs shall meet the following criteria: (1) New stairs shall be in accordance with Table 7.2.2.2.1.1(a) (2) Existing stairs shall be permitted to remain in use, provided that they meet the requirements for existing stairs shown in Table 7.2.2.2.1.1(b) (3) Approved existing stairs shall be permitted to be rebuilt in accordance with the following: (a) dimensional criteria of table 7.2.2.2.1.1(b) and other stair requirements of 7.2.2 (4) The requirements for new and existing stairs shall not apply to stairs located in industrial equipment access areas where otherwise provided in 40.2.5.2. <p><b>NFPA 720- 5.5.6.1 CO ALARMS REQUIRED;</b> The performance, location, and mounting of notification appliances used to initiate or direct action, evacuation or relocation of the occupants, or for providing information to occupants or staff, shall comply with the requirements of Chapter 6.</p> <p>No CO alarms present in apartments 8, 11, 12, 28 and 34.</p>	6/1/18
<p><b>NFPA 101- 31.3.4.5.1 SMOKE ALARMS REQUIRED;</b> In buildings other than those equipped through out with an existing, complete automatic smoke detection system, smoke alarms shall be installed in accordance with 9.6.2.10, as modified by 31.3.4.5.2, outside every sleeping area in the immediate vicinity of the bedrooms and on all levels of the dwelling unit, including basements.</p> <p>None of the one or two bedroom apartments have smoke detectors in the sleeping areas.</p>	6/1/18
<p><b>NFPA 101- 8.2.3 FIRE RATING NOT MAINTAINED;</b> The fire resistance of structural elements and building assemblies shall be determined in accordance with test procedures set forth in NFPA 251, ASTM E 119, ANSI/ UL 263, or other approved test methods, or analytical methods approved by the authority having jurisdiction. Materials used to construct fire resistance-rated elements and assemblies shall be limited to those permitted in this code.</p> <p>Sheetrock around newly installed Lally Column in Boiler Room needs repair.</p>	7/1
<p><b>NFPA 70 MISSING BREAKER IN PANEL;</b> Refer to NFPA 70, National Electrical Code, for information on missing breakers in an electrical panel.</p> <p>Knockout missing in Electrical Panel.</p>	
<p><b>CITY OF PORTLAND CODE CHAPTER 10- 21.5 HAZARDOUS MATERIALS MANAGEMENT CABINET REQUIRED;</b> Buildings required to comply with tier 2 shall provide a hazardous materials management cabinet on the exterior of the building. This shall also comply with Section 10-21.5 of Portland City Codes.
