Deck Proposal

John J. Marmo Jr. 23 Fairview St. Portland, Me. 04102

After repairing woder damaged sunpourch or mudroom walls, I decided to add a rear door to the mudroom and possibly add a deck of the back of the house.

The deck will span approximately 16'(feet) out away from the real of the house for 8' of its overall length and then span approx. 18' 10" away from the house for another 16' bringing the overall length across the back of the house to 24'. The deck will thus be approx. 425 sq. feet. The deck will also be a least 23' away from any side lot and 75' away from the back 16t.

The deck will be attached to the house with the use of joist hangers and a ledger board. The ledger board will be attached with carriage bolts and lag bots. The dock construction will be of 5/4 decking on top of 2x8 joists spaced 16" o.c. (on center) with no more than an 8'6" span between supports of 2' overhang. The deck frame will rest on top of 2 beams of triple 2×12 construction.

These beams will rest on 6 6x6 posts which will be secured to 6 12" diameter concrete footings spaced a max, of 10' apart in the direction of the beams span and approx, 8'6" apart in the direction of the joists span. There will also be no more than a 2' overhang of the beam. The concrete footings will reach 4' to 4'6" below the ground surface and be reinforced with 4 pieces of 4' rebour.
