Hi Cameron, following up on my previous message, you should check to make sure your property contains soils that are suitable for the installation of a drywell. The NRCS website is very helpful for identifying soil types.

http://websoilsurvey.nrcs.usda.gov/app/WebSoilSurvey.aspx

You should also make sure that the installation location of the drywell is at least ten feet from all property boundaries. In addition, when you submit your application please include a specifications sheet of the type of drywell you will be using, and the construction details for its installation. I've attached the City's Stormwater Credit Manual, with a section on drywells, that may help to guide you with your design and installation.
