Thanks for sending the fast track application.

The revised site plan does show the front and rear setbacks. I still need to know what the side setback is going to be. Is it one foot? Half a foot?

The numbers for the ramp and landings still don't make sense. The notes say that the ramps are $5' \times 10'$ yet the landing is only 8' wide and the number at the bottom says the ramp is 3' 6" wide. Are each ramp 10' long by 3' 6" wide and the wedge 5' long by 3' 6" wide?

Please send a revised site plan that shows this.

The C1 Structure Plan and the site installation plan show two different setups. I understand that the ramps are 5 in width. The C1 Structure plan shows a a 5' x 5' ramp and a $10'$ x $5'$ ramp coming off the top landing and a $5'$ x $10'$ ramp to a $5'$ x $5'$ wedge to the ground from the mid point landing. The site installation plan shows a $10'$ x $5'$ ramp coming off the top landing to the mid point landing. Also, how big are the two landings? Sheet C1 shows the large landing as $5'$ x $8'$ although the mid point landing would have to be $5'$ x $10'$. I did not see a dimension for the smaller landing at the top.

I left you a voicemail. I need some more information before I can sign off on the permit.

First of all, this permit can be fast tracked, but you need to fill out the two page fast track application and send the pdf to me. I have attached the form. By applying for the fast track application, it means that the permit only has to be reviewed by zoning because by signing the form you are guaranteeing that the ramp will be built to code.

Second, I need more information on the actual sizes of the landings and ramp sections. The site plan shows the length of the two long ramps as 10' but what are their widths? Also what are the exact sizes of the two landings one by the door and the one midway?

Third, I need to know what the exact setback is to the side property line and what the setback is to the rear property line for the proposed ramp.

Finally, I will issue the permit as soon as I get the information I need, but the owner will have to do a disability variance.
