We will be repairing our garage. The garage was built on top of a tar driveway. The tar has given way on the sides and the bottom boards of the garage have rotted causing garage to lean.

The boards in the garage going up and down are 23 inches on the center. The side walls are tounge and groove 7 1/2 boards.

We will jack up the garage and replace 4 of the 7 1/2 tounge and groove boards around the bottom. We also will pour a cement slab underneath. The thr has given away and this will prevent the bottom boards from rotting again. If we can not afford the cement slab, then we will put some cement blocks along the underneath so that the bottom of the garage will not be sitting on the ground.
