James Fenton Jr., and Jeanne Fenton**, their heirs and assigns forever, with WARRANTY covenants that certain lot or parcel of land, together with any improvements and buildings thereon, situated in the City of Portland, Cumberland County, and State of Maine, described as follows:

A certain lot or parcel of land with the buildings thereon situated on the northwesterly side of Rosemont Avenue in said Portland being lot numbered sixty-five (65) as shown on Plan of Rosemont recorded in Cumberland County Registry of Deeds in Plan Book 11, Page 29, to which Plan reference is hereby made for a more particular description of said lot.





