City of Portland Maine - Ruilding or Use Permit

- 1) The review of this permit did not include a review or confirmation of the zoning legal use. It is only approving the specific work described in the plans and forms submitted. The current use of the property may be found to be unlawful.
- 2) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process.
- 3) This is being issued with the understanding that as a fast track, the owner is responsible for scheduling inspections for the work being done and the inspector may require modifications to the work that has been completed if it does not meet code.
- 4) Per the 2009 IRC Sec. R305 and the 2015 UPC plumbing code, bathrooms shall have a ceiling height of 6'-8" at the center of the front clearance at the sink and toilet and at the showerhead above a minimum area of 30"x30". Front clearance at the sink and toilet shall be a minimum of 24".
- 5) This permit is being approved on the basis of plans submitted. Any deviations shall require a separate approval before starting that work.
