If the conditional use is only for 2 years then what happens? The conditional use is not time limited.

I don't see where the traffic study addresses the problem we have turning left out of Lassell St. The exit from the shopping center next to the building makes it almost impossible to get out of our street between lights on Stevens Ave. I've been complaining for years that that exit should be blocked. There will be more weekday traffic, making it harder than ever to get out and turn left. I'm glad that the daycare and play areas are on my side of the building because occasionally cars sneak in the exit and they really gun it and I'm surprised that they haven't hit a pedestrian yet. I am not quite sure what you are referring to. Our Traffic Engineer wants everyone from his project and from the dental offices who what to turn left onto Congress to use the proposed drive and parking lot to get to the Westgate exit where there are signals that allow a safe left turn. A formal agreement between the applicant and the dental offices has been made to allow that access. You would be able to do the same (drive through the dental parking lot and turn left etc to get to the signals). The number of vehicles that would be doing this is small, even adding in Lassall.

I'm also have concerns about how the landscaping affects my property. Please let me know what they are- our City Arborist reviews the landscaping and I meet with him on wednesday morning. You can telephone me if you would like.

Is the July 14th date firm. It seems that when we get a date, it gets changed to when we've made plans to get away. I am sorry that its not convenient for you but it is not something that I have any control over. I am on vacation that week but will be coming back for the Planning Board meeting.
