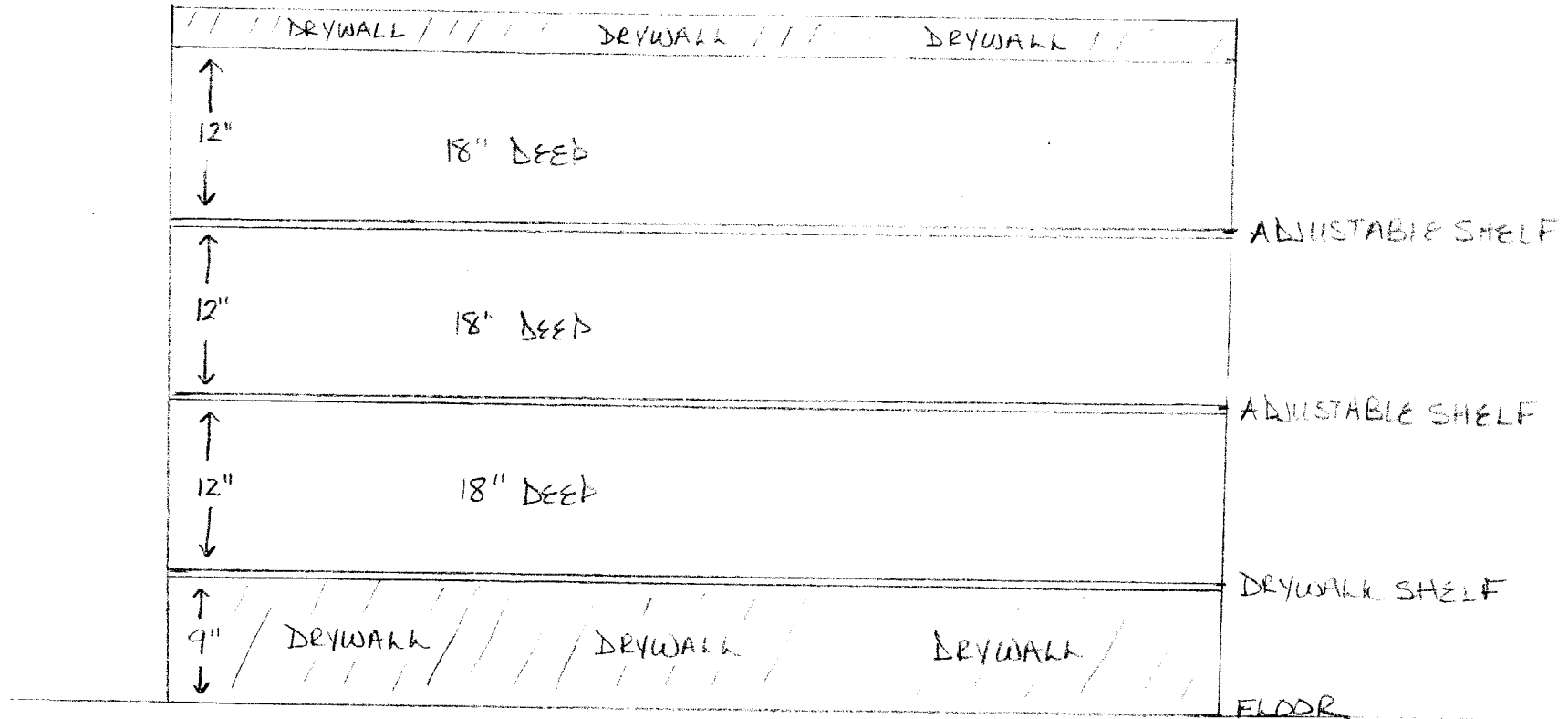

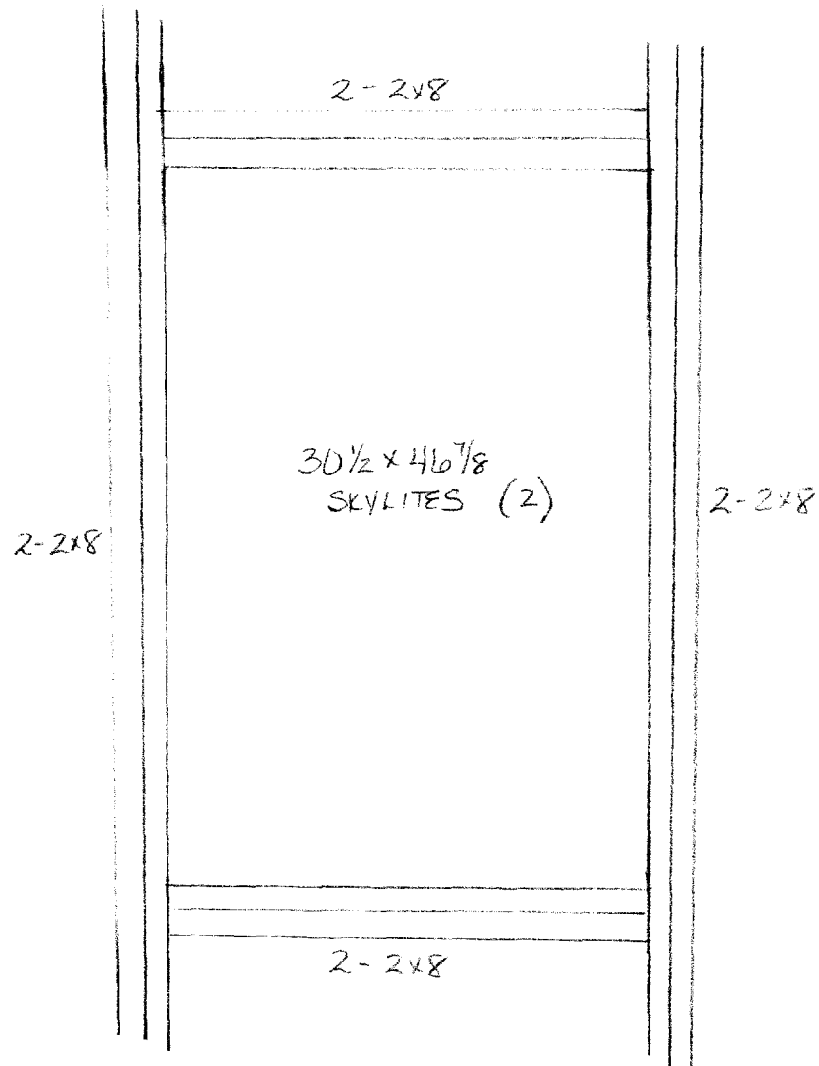
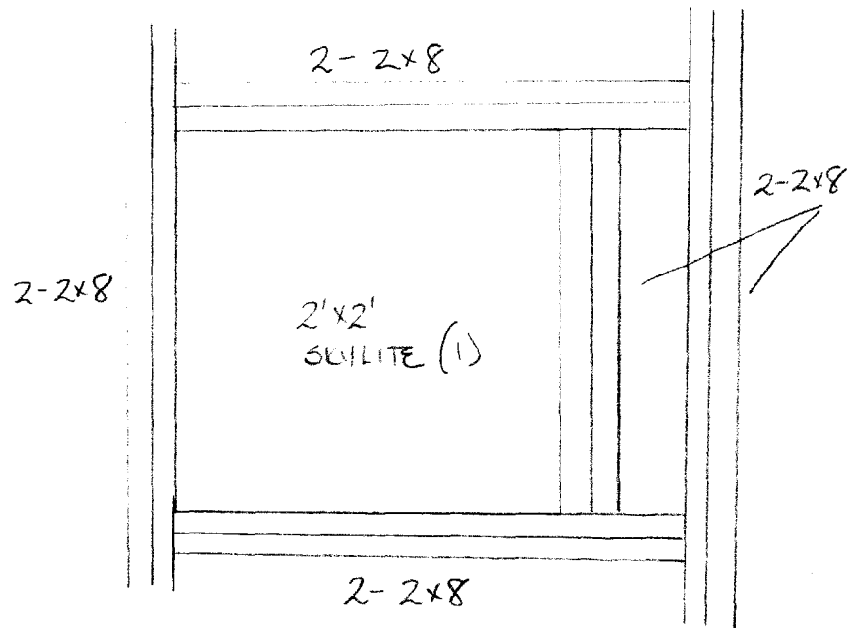
FRONT VIEW OF

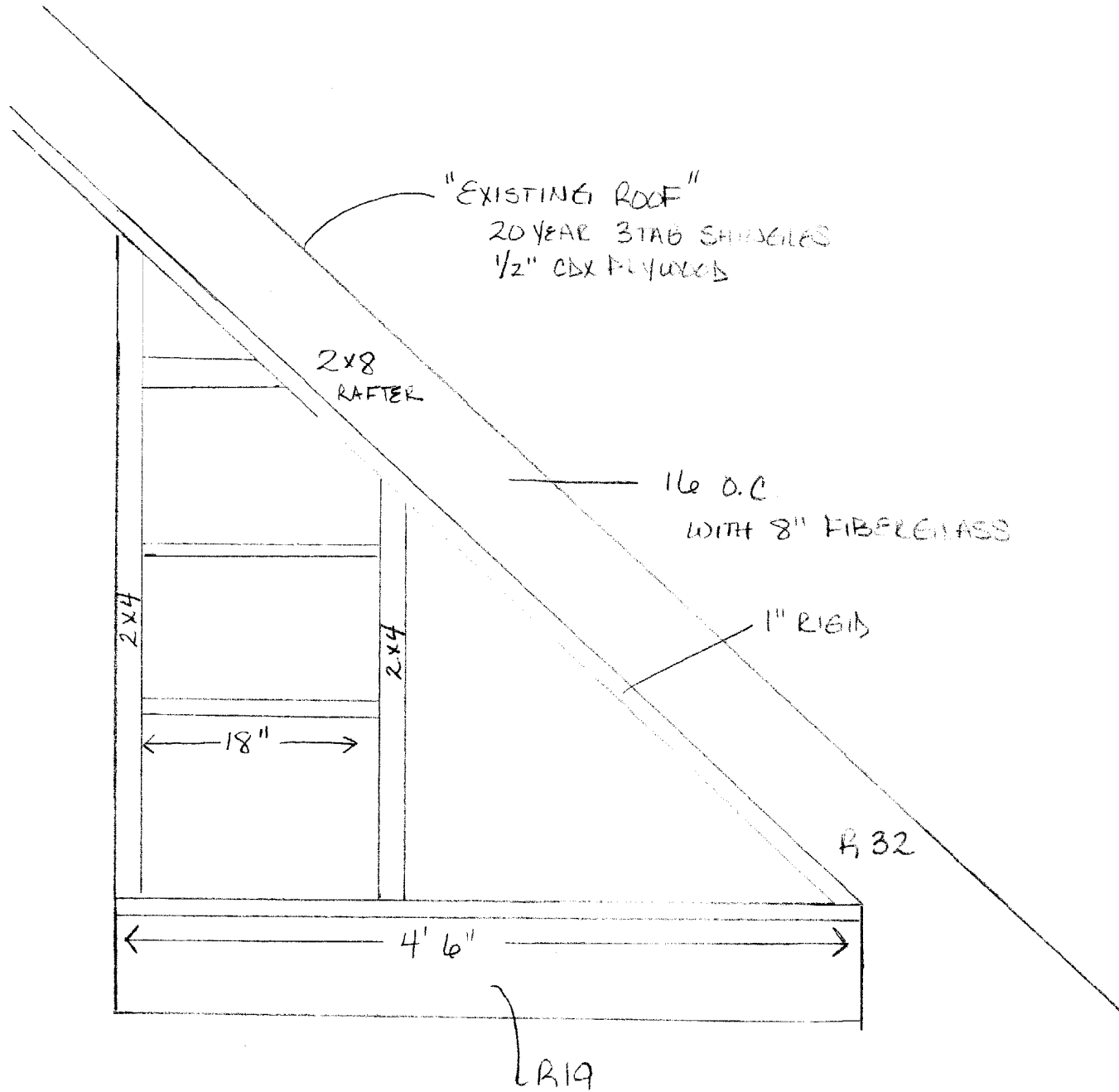

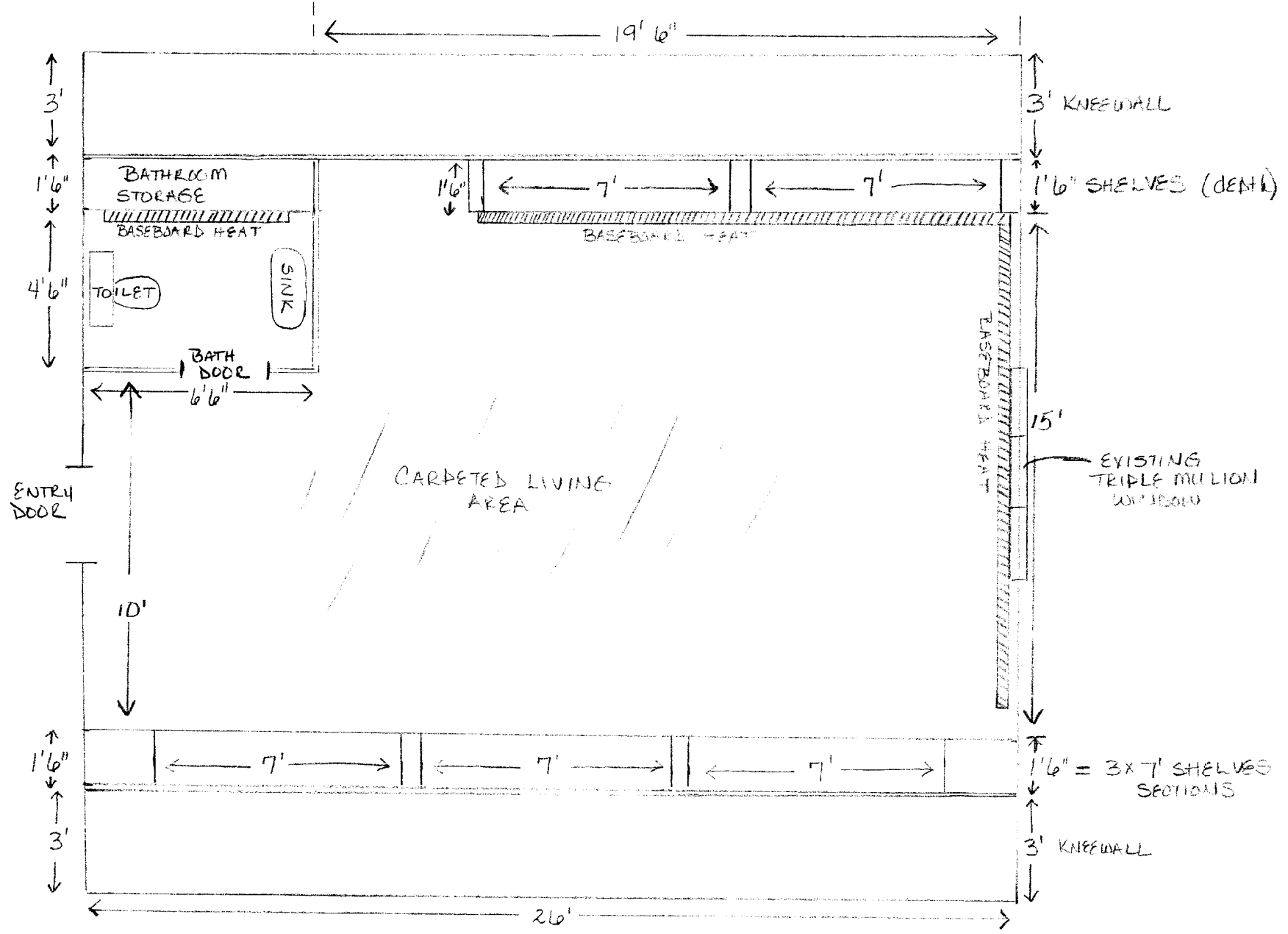
