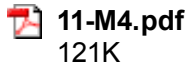

Michael. We currently don't enter permits instantly as they come in. This is our busiest season and permits come in faster than they can be entered into the system. Once they come in, they are put in our e-mail que and we go through them in date order. That's what the previous e-mail was explaining. The fast track form does provides you a quicker **review** because the code compliance responsibility rests with the applicant and does not go through that review here, but that is done after the permit has been entered and paid for. You were sent the process before. That should explain it very well.

Just to be completely clear:

On May 19 we submitted an application for the full construction project. On May 25, yesterday, Rebecca Darling paid the invoice for Permit 201601360. As I understand it, that permit is now in the pipeline for processing.

Yesterday we stopped in your office and asked if we could file a demolition and HVAC permit application under a fast track request so we might be able to begin work on demolition and HVAC while waiting for the full permit. I filed that permit application this morning.

Given that, as you noted in an email to me, the HVAC permit needs to be filed separately, I deleted the HVAC permit portion of our request, and submitted a clean application and fast track request for demolition only.

It is my understanding that the new demolition permit application is now in your email queue, and will be processed in order of receipt.
