Attached are the stamped Architectural drawings. They include the revisions you noted as well as the missing sheets.

The existing stair is wood-framed. We designed the extension of that stair to match for ease of anchoring to the mid-level platform.

We eliminated the window in the fire-rated stairwell. The second floor walls at the perimeter of the office/conference room are not fire rated, therefore the windows in those walls are not either. Hope this is clear as mud!
