Jim, we charged you incorrectly. If you review the permit application, it states that there is a \$30 charge for EACH event, tent, stage, etc. Technically you will be doing 18 events (18 total Saturdays, not including 4th of July). The attached updated invoice shows this change. We did receive a \$30 check, so the attached shows the balance. Once we receive the balance, the permit will start the review process.
