**Subject: Ice Rink at Thompson's Point – Nov. 2015 / March 2016  
Thompson's Point, Portland**

Dear Tammy:

I am pleased to submit this package of materials detailing the seasonal Ice Rink under the Depot at Thompson's Point.

The ice rink will feature:

1. 60' x 120' skating rink
2. 8' x 40' ticket office and skate rental shop
3. 6' x 12' winterized 2-station bathroom trailer and 2 portable bathroom stations, with the ability to add stations if necessary
4. 30' x 30' warming hut
5. 8' x 40' lounge
6. Food truck up to 8' x 30' footprint
7. 12' x 20' equipment garage

The rink will be in operation from Thanksgiving weekend through the end of school vacation break in February. We anticipate being open seven days a week except for select holidays and operating between 10 a.m. and 10 p.m.

Staff had requested more specific information regarding forecasted capacity. Based on our discussions with the rink operators, we estimate that the facility will accommodate up to 150 patrons at a time in its peak use, with an average of approximately 30-50 patrons during non-peak times.

Per staff request we have also provided detail showing protection around the electrical service and temporary chiller, additional snow loading data for applicable structures, and additional floor plan information for item #5 above.

The facility will be configured to accommodate up to 150 patrons at a time.

Food concessions shall be provided by a licensed food truck and on a limited schedule we also plan to offer beer and wine sales managed by a licensed caterer. Food concessions and alcohol service shall be licensed independently in accordance with State and City law.

All electrical work shall be permitted separately, performed by a licensed electrician and inspected.

1. **A1 Ice Rink Access Plan:** This drawing illustrates the existing buildings at Thompson's Point, along with vehicle access roads to the rink and parking area allocated to the ice rink activity on Thompson's Point.
2. **A2 Site & Rink Layout:** This drawing illustrates the ice rink layout within the Depot at Thompson's Point including rink size and location, facility locations (including tent location and size, entrance and egress locations and sizes), and operational infrastructure.
3. **A3 Entrance and Egress:** This drawing indicates the primary entrance, a supplemental exit, and the public space off-ice beneath the Depot.
4. **B1 Power Distribution:** 800 amps three phase power supply and distribution
5. **B2i Ice Chiller:** Aggreko 100-ton ice chiller
