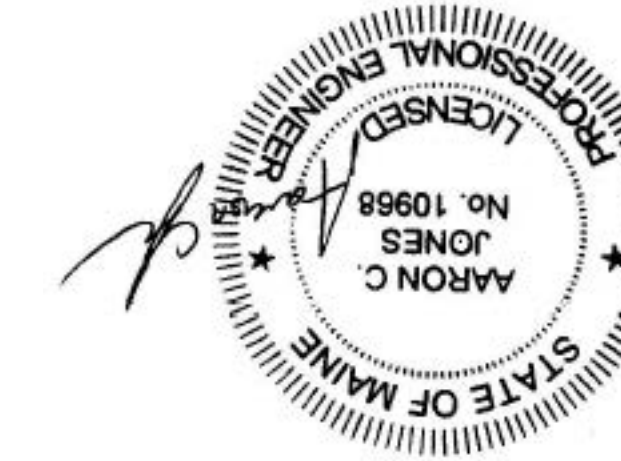

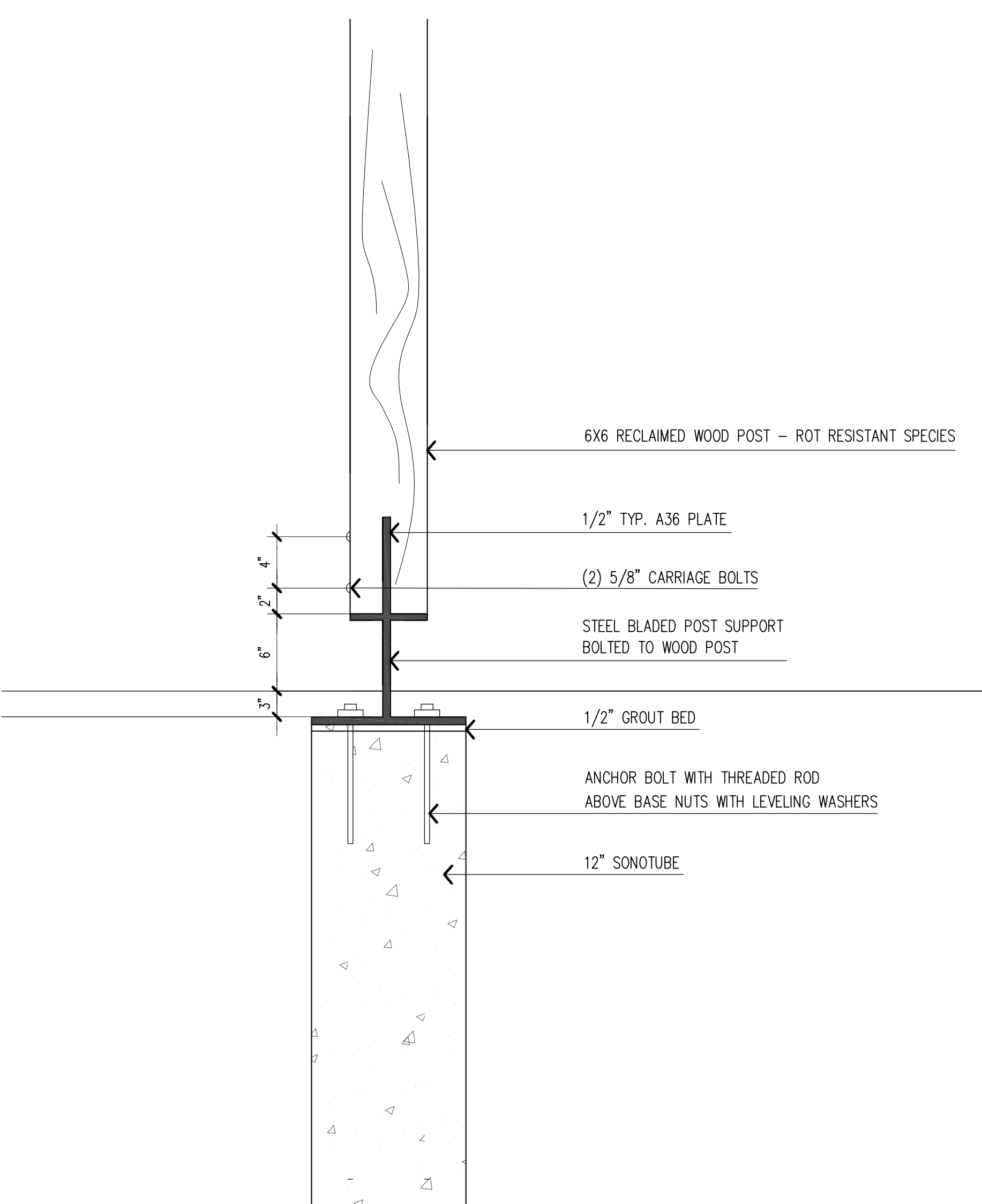

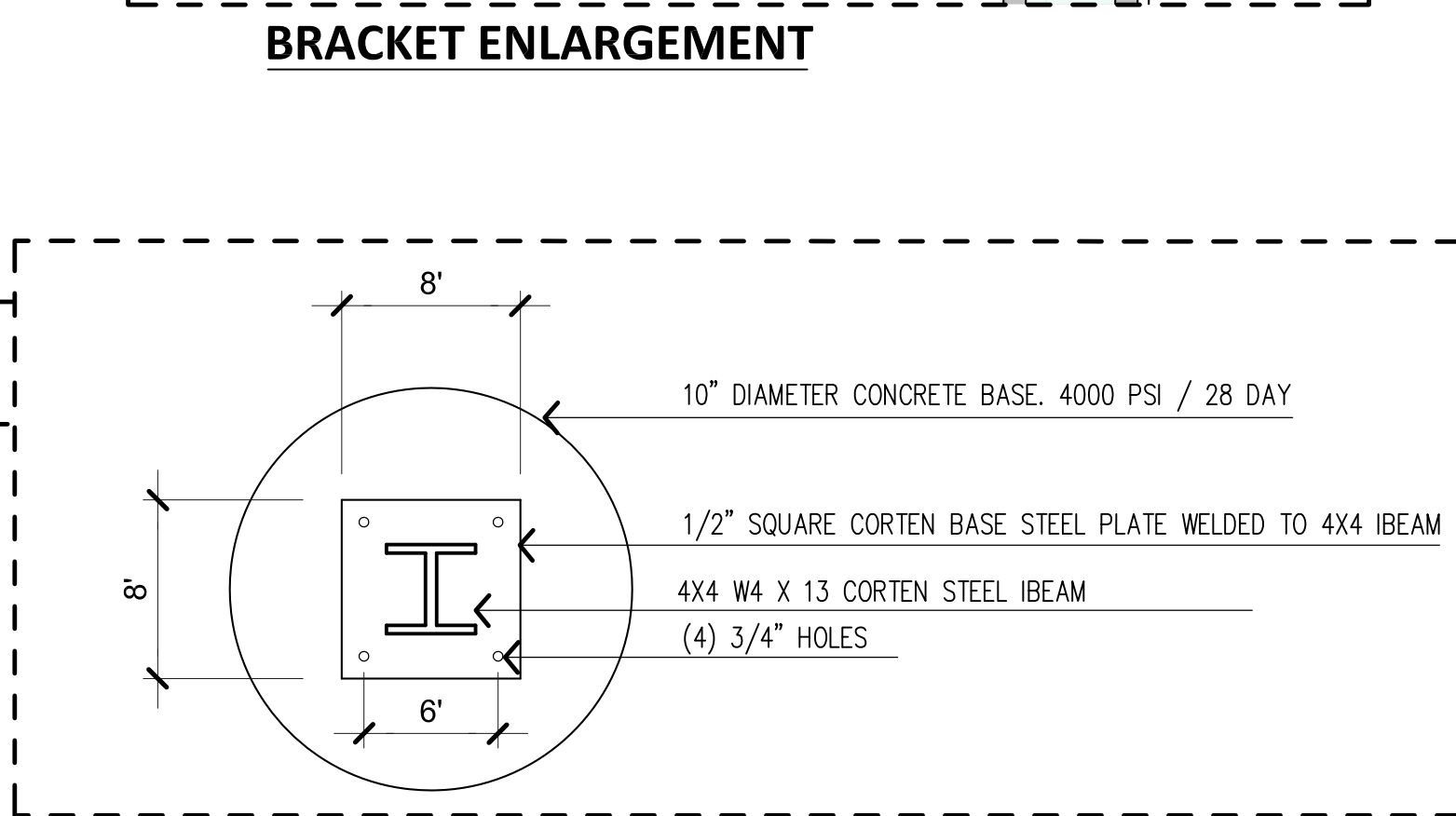
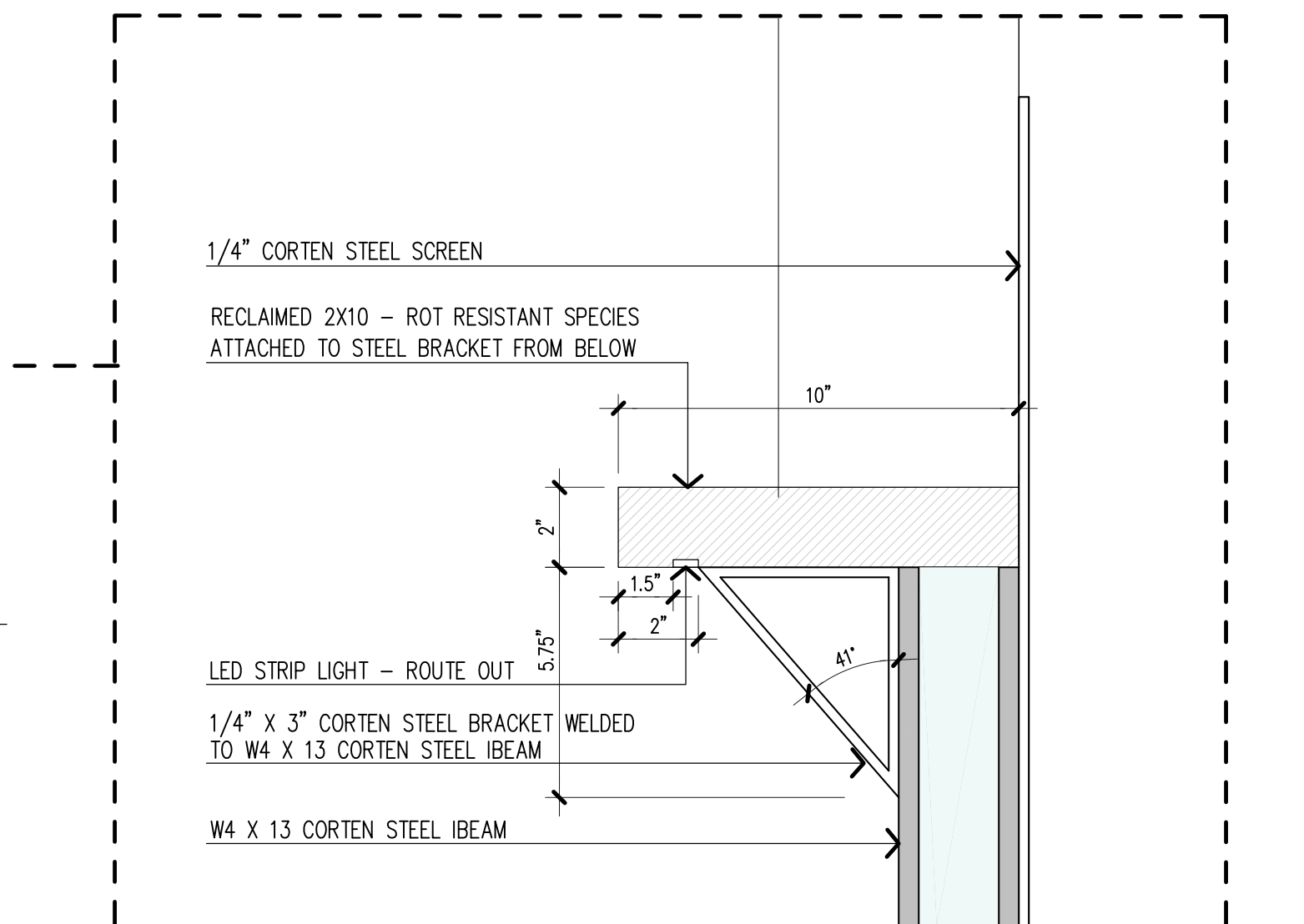
1 RECLAIMED POST / TRELLIS (NORTH SOUTH SECTION)
