Scope of work -

The renovations at Unum will consist of three phases. Phase 1, included in this permit application, includes the renovation Level 1, Level 2 and a small area of the Ground Level of Unum HO2 with a square footage as noted above. The scope will include selective demolition of the existing area, the addition of new drywall partitions, new finish carpentry, new flooring, new ceilings, new light fixtures, electrical, tel/data, HVAC grilles and diffusers. Plumbing will be added to support the new common area spaces. The life safety systems will be re-worked to accommodate the new floor plan and finishes. A band of precast façade will be removed and replaced with new windows to match the remainder of the building.

Phases 2 and 3 will be issued under a separate permit application.

State Fire Marshall Permit -

After review with the code enforcement office, it was confirmed that the building permit and State Fire Marshall Permit reviews will happen in parallel. The SFM permit will be provided to the code enforcement office upon receipt.
