EXHIBIT A

A certain lot or parcel of land, located along Riverview Street in the City of Portland, Cumberland County, State of Maine, more particularly bounded and described as follows:

BEGINNING at the southwesterly corner of Lot 33 as shown on a plan titled "Plan of Capisic Heights Portland, ME Surveyed Jan, 1913" by A.E. Skillin, Surveyor and recorded at the Cumberland County Registry of Deeds in Plan Book 12, Page 75, said point located along a one foot strip of land as shown on said plan and described in a deed from Cora M. Edwards to the City of Portland dated February 28, 1945 and recorded at said Registry in Deed Book 1826, Page 435;

THENCE N 21° 57' 14" E 87.50 feet along said one foot strip, the westerly line of Lots 33, 31, and 29 as shown on said plan to a point at the most southwesterly corner of Lot 27 as shown on said plan,

THENCE N 26° 26' 50" E 3.27 feet along said one foot strip and the westerly line of Lot 27 to a point;

THENCE S 73° 45' 24" E 114.42 feet through said Lot 27 and running parallel with the southerly line of Lot 27 to a point along the westerly line of Riverview Street;

THENCE S 16° 14' 36" W 133.45 feet along the westerly line of Riverview Street to a point along said one foot strip, said point located at the southerly corner of Lot 33;

THENCE N 54° 31' 15" W 131.02 feet along said one foot strip and the southwesterly line of Lot 33 to the **POINT OF BEGINNING**.

Said lot or parcel of land contains 13,430 square feet, more or less.
