Separate plans may need to be submitted for approval as a part of this process.</li> <li>3) This is being issued with the understanding that as a fast track, the owner is responsible for scheduling inspections for the work being done and the inspector may require modifications to the work that has been completed if it does not meet code.</li> <li>4) This permit is being approved on the basis of plans submitted.
