I am following up on your comments at Dev Rev this week.

I just spoke with David Latulippe, the developer of this project- I asked about the changes in the stormwater system.

He explained that the underground detention was not needed as the other one could be expanded (it was previously constrained by wetland), and the stormtreats had been included before because they had anticipated a connection to Skyway Drive and therefore over-designed the original site plan system. Now the connection to Skyway is not anticipated the engineers suggested they do not need to be included now; the engineers advised David that the stormtreats could be added in future if an extension towards Skyway is added back in.

He indicated that MDEP had recently approved a project in Scarborough almost exactly as now proposed for this project. He also suggested you might want to speak to Bo Kennedy direct for further background on this.
