(A 24 hour notice is required prior to inspection) "<u>ALL</u> LOT LINES SHALL BE CLEARLY MARKED BEFORE CALLING." Foundation drain shall be placed around the perimeter of a foundation that consists of gravel or crushed stone containing not more than 10 percent material that passes through a No. 4 sieve. The drain shall extend a minimum of 12 inches beyond the outside edge of the footing.
