- **1.** The General Building Permit that you submitted is blank. Would you please send us a completed permit application? Please write the dimensions of the two new roof structures on your building permit.
- **2.** Please submit a plot plan that includes the dimensions of the new roof structures on the footprint including dimensions showing how far out the new structures extend from existing roof.
- **3.** Submit a simple front elevation sketch of the whole structure and where on the structure the new roof additions will be located.
- **4.** Please specify the material of the support beam and support beam dimensions.
- **5.** Submit a sketch showing how the support beam/bracket will be attached to the house. Are you attaching it to plywood, a stud?
- **6.** Specify whether the doors are existing doors.
