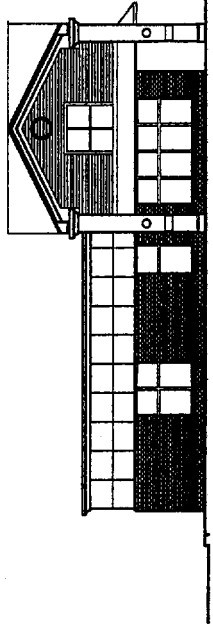
1 RETAIL TWO EAST ELEVATION

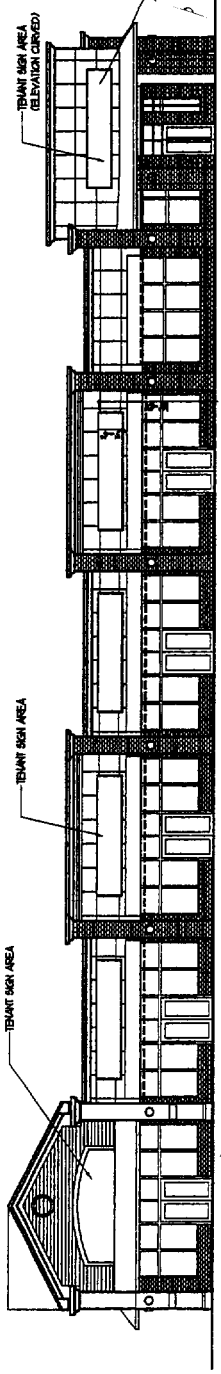


1 RETAIL TWO SOUTH ELEVATION

This text must appear as the sign over the main entry at every location. The text may be arranged as two lines, stacked or all on a single line. Capped, internally illuminated pan channel letters are to be mounted either individually, on the building sign band, or on a raceway, depending on local conditions. This is Quizno's minimum required sign installation. When permitted by the Landlord or Owner:

- There should also be signs and/or awnings placed directly over every public entrance into the store.
- In addition to the exterior sign, Quizno's also specifies canvas shed style awnings to further enhance the exterior appearance. The awnings usually run below, or in line with the letter signs.
- If the location is an end cap with good visibility, it should also have signs and awnings for the front, side and rear (and a pole sign too, if possible).
- Interior neon window signs (see attached sample specifications) should be displayed in the storefront windows.

The sign program should maximize visibility and aesthetics while working within the budgetary guidelines established.

Quizno's standard sign specifications call for pan channel letters with white Lexan faces and the use of the Quizno's specified **3M** VT vinyls over the white with the use of the Green and Red sign (see attached sample specifications).



White colored buildings:	QUIZNOS	Green face, green trim, black returns, green neon
	SUB	Red face, red trim, black returns, red neon
Any other colored buildings:	QUIZNOS SUB	White faces, bronze trim, bronze returns

The neon should be left on during all hours of operation to provide good visibility. Quizno's standard for mounting the letters is flat on the building surface. Some locations may require the letters to be mounted on exposed "raceways" to preserve the surface of the building from drilling. The raceways are to be painted to match the color of the building, unless otherwise specified by the Landlord or Owner.

Channel Letter Visual Standards

- o The custom “Quizno’s Green” VT#11399 and “Quizno’s Red” VT#11398 vinyl, manufactured exclusively for Quizno’s by 3M, must be used and applied as a first surface application.
 - Any other color except for white (see below), or any variations of the corporate colors will be unacceptable.
 - When using white faces, the trim cap must be bronze and the returns must be bronze.
 - Green and Red letter faces must have a first surface vinyl application; white faces must be white acrylic with a flat or matt finish.
 - When using the green and red faces: the word “Quiznos” must be the corporate green color and the word “Sub” must be the corporate red color.
 - ® Registered and ™ Trade Mark symbols are not to be used or included in any signage.

- o The letter faces will be a flat or matte finish.
 - Gloss finishes that reflect light in the daytime or appear as distorted or to be “oil canning/wavy” because of the reflection are unacceptable.

- o The proper **logo** and/or spelling must be presented.
 - “QuiznosSub” is the proper spelling.
 - The apostrophe has been eliminated from the word “Quizno’s”.
 - The lower case “s” has been eliminated from the word “Subs”
 - The  is the new logo and is **always** used in conjunction with “Quiznos Sub” and never alone. When the  is used with white letters, then it is completely white, no green or red.

- o The signs must be properly illuminated.
 - The illumination for each letter must be brightly illuminated. Dim signs are unacceptable. Light leaks should not appear anywhere around the edges of the faces, returns, top, or back, of the letters. The only expectable light leak may come from the bottom of each letter where weep holes are located to allow for any moisture or water to drain.

- o The proper color for “returns” and “trim cap” must be used.
 - The standard color for the returns is bronze when using white faces and black when using green and red faces. Any other color is unacceptable.

- o The current standard color for the trim cap is bronze for white faces, green for green faces, and red for red faces. Any other color is unacceptable.

Awning Visual Standards

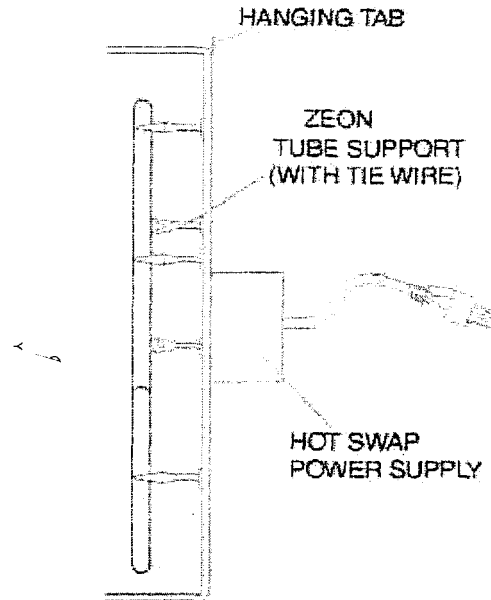
- o Shed style canvas awning with 48" high by 48" deep with a 10" valance.
- o Awning material will be canvas, by "**Sunbrella**", color Forest Green.
- o White vinyl graphics applied on awning incline or valance.
- o White only "**Q**" logo can be used on awning incline.
- o White only "**Quiznos Sub**" logo can be placed on the valance.

It is the responsibility of the Quizno's Area Director, Franchisee and the approved sign vendor to evaluate the location & develop a suitable sign package for approval **by** the Landlord or Owner and **by** Quizno's. Once submitted to Quizno's, the approval process requires a minimum of five business days.

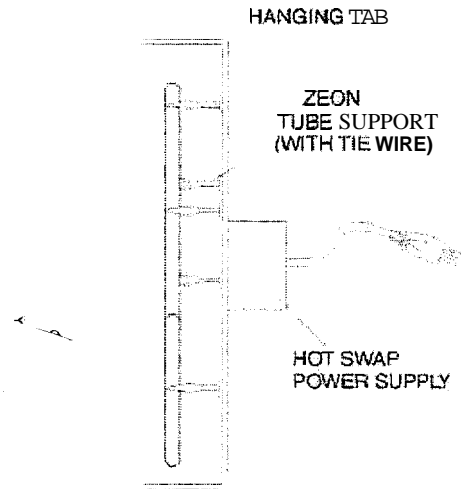
