The existing W12 structural steel beams can adequately support the new roof top unit with a maximum weight of 650 lbs. Casco Bay Engineering also inspected the existing bar joists in the service area to support new infrared heaters. New heaters are to be hung from the bottom chord of the existing bar joists and at bar joist panel points only. Please note that Casco Bay Engineering did not analyze or design any other portion of the service bay area of the building.


