All of the following information is required and must be submitted. Checking off each item as you prepare your application package will ensure your package is complete and will help to expedite the permitting process.

One (1) complete set of construction drawings must include:

| Proof of ownership is required if it is inconsistent with the assessors records. |
| Reduced plans or electronic files in PDF format are required if originals are larger than 11" x 17". |
| Per State Fire Marshall, all new bathrooms must be ADA compliant. |
| Separate permits are required for internal and external plumbing, HVAC & electrical installations. |
| or additions less than 500 sq. ft. or that does not affect parking or traffic, a site plan xemption should be filed including: |
| The shape and dimension of the lot, footprint of the existing and proposed structure and the |
