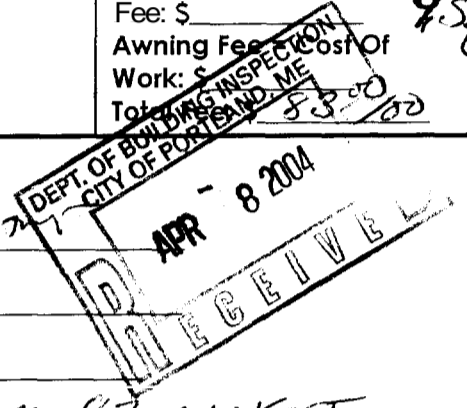


# Signage/Awning Permit Application
