An evaluation of the above reference property on <u>6/14/2012</u> shows that the structure fails to comply with Chapter 12 Article V of the Code of Ordinances of the City of Portland, The Garbage, Wastes and Junk Code. Attached is a list of the violations.

This is a notice of violation pursuant to Section 12-79 of the Code. All referenced violations shall be corrected within 30 days of the date of this notice. A re-inspection of the premises will occur on 7/16/2012 at which time compliance will be required. Failure to comply will result in this office referring the matter to the City of Portland Corporate Counsel for legal action and possible civil penalties, as provided for in Section 1-15 of the Code.

This constitutes an appealable decision pursuant to Section 12-80 of the Code.

Please be advised that the Portland City Council has amended the Building regulations to include a \$75.00 re-inspection fee. This violation will automatically cause a re-inspection at no charge. If there are any subsequent inspections, however, the \$75.00 fee will be assessed for each.

1. JUNK VEHICLES-City Ord. § 12-79

It shall be unlawful for any person owning or occupying private property in the City to keep or allow to accumulate any old, discarded, worn out or junked motor vehicle, or parts thereof, on private property after having received written notice form the City, by the City Mananger or by an official designated by the City Mananger, ordering the removal from the property upon not less that thirty (30) days from receipt of the order of the old, discarded, worn out or junked motor vehicle, or parts thereof.
