Suzanne,

Two days before you called I was planning on taking care of the mattress and organize the recyclers that were next to the house. And work at my storage area getting thing moved around so I could get my platform in that was built to put those items from my yard. My plan was to have it up this weekend, but I was trying to move parts of my platform to my trailer when I pulled something in my shoulder. I went top the MMC and they informed me that I had pulled the tendons in my shoulder. And from now until it is fixed, I am not to lift anything at all. (It is in writing) And I have limits to my left shoulder which will need possible surguery.

I slowed down due to the fact that in November, I had pneumonia and I was for the most part in bed sick. And trying to stay away from my mother due to her health problems. But she ended up getting a cold that basically put her in bed for a week. So I spent a week taking care of her and keeping in contact with her doctors. And this was because she has cancer and if this cold turned to pneumonia, she could have been in serious trouble.

My goal is for this month:

- 1. This week completing platform at my storage area. Reorganize area to make room. and time allows, do items bellow)
- 2. Remove ATV Tires from yard
- 3. Remove items colleted near rear stairway of the house.
- 4. Remove misc. items from next to shed.
- 5. Call you to see if what is done is enough.

There is a ATV on a small trailer and a snowblower. These two items belong to a friend of mine that loaned us the money to junk the boats. In exchange, I am to repair the ATV and replace the motor on the snowblower. This will pay the loan back. And the sooner I get done being harassed by the neighbor, the sooner the work will be done and it will be gone.

I am not sure if I will be available due to the fact I may still be sleeping due to pain killers. They gave me thay Ovycontine. (Spelled it wrong I am sure)

I ask to give me the month and will keep in contact with you. The reason for them calling is that they are aware that my mother has cancer, and I am sick also and having a hard time. They are aware my sister in law is going to die. (just found out) And they love kicking us while we are having these problems. Kick us while we are down. They did it back in 5/99 when my father died of ALS. They called the day we buried him. I ask that you give me the month because I am trying to avoid stressing my mother. (told by doctor) The trip to Dana Farber was not good, and I spoke to the doctors and was told that future treatments should be there. After Christmas, we are going to have a meeting with her to tell her. They told me to keep her calm as possible and no stress. And she is now because it is obvious we are being attacked by a neighbor trying to control our lives. But Iwill tell you, she may not be here by summer. Which means I will be gone also with what I own. I hate Portland, because I have no rights and my

neighbors do.

When this is over, I want to have a meeting with the department head to discuss the Inspections willing to be a tool to get at us. Two other violators on this street and they do whatever they want,. Why? They kiss her Butt. At SMCC Criminal Justice, they tell students that "Laws are passed and no one is exempt from them" But in my area of Portland, they are. It was obvious to other inspectors we spoke to that this was more personal thab anything else.




