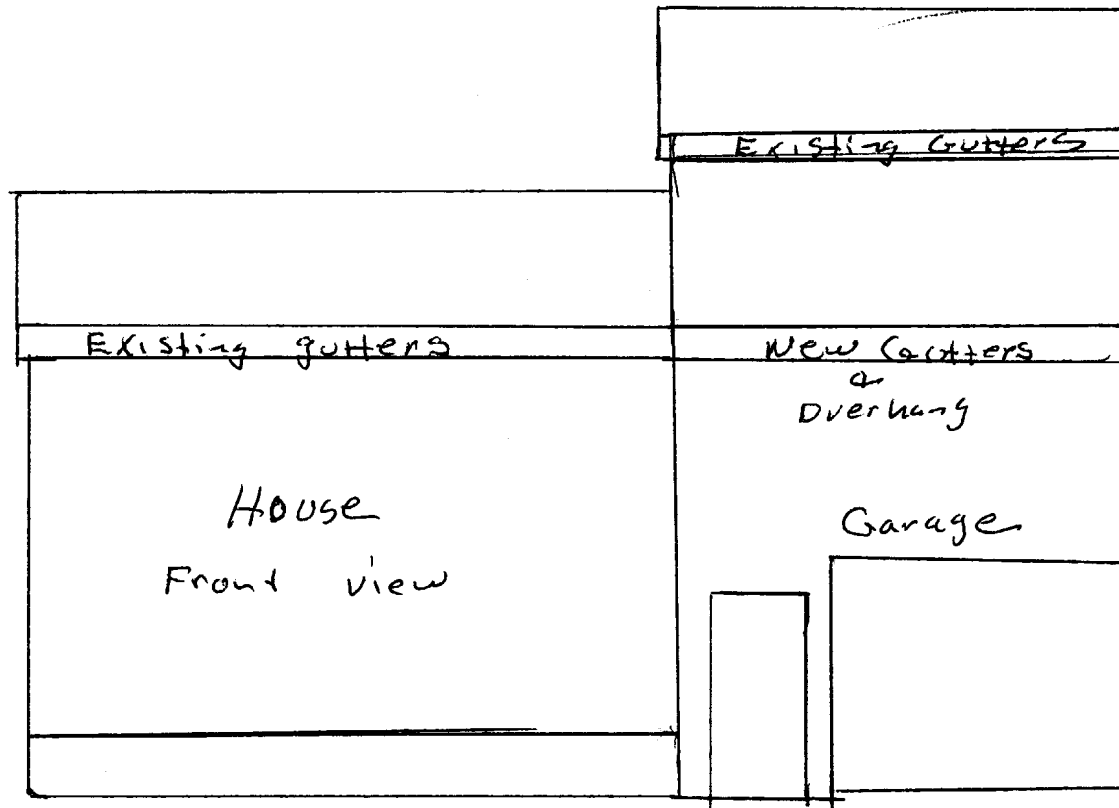
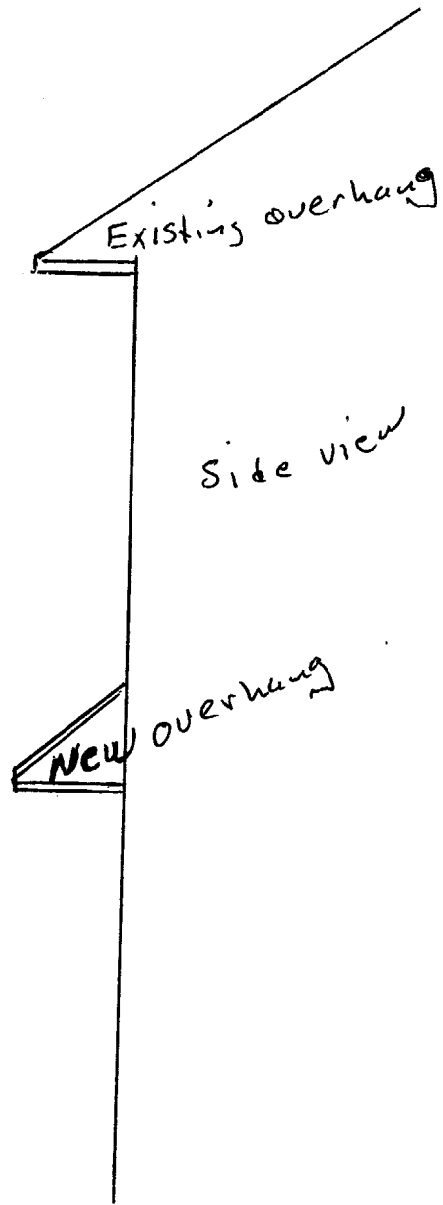
FRONT FRAMING ELEVATION
