Thank you for inquiring about the status of your Demolition Permit #2017-00203 issued 2/28/2017. Per City Code 6-23, demolition permits expire 30 days after the date of issuance. You have informed our office that the demolition is slated to take place during the month of May, possible into June 2017. In lieu of re-applying for this work, this email confirms that the permit remains in good standing and the demolition permit will be extended until June 15, 2017.
