Re: Building Permit Application for the Central Maine Power Co, Inc. (CMP) Bishop Street Substation, Portland, Maine

Dear Doug:

Enclosed is the General Building Permit Application and supporting plans for CMP's plans to add various electrical components to its Bishop Street Substation. CMP is committed to improving electrical service to businesses and residents in the Cities of Portland and Westbrook and is proposing improvements to the substation to upgrade the electrical distribution circuits. The substation is served by two 34.5 kV transmission lines, Sections 186 and 188, which support three distribution circuits that provide power to the Morrills Corner area including Warren Ave, Forest Ave, University of New England, numerous residences, and commercial and industrial businesses in Portland and Westbrook.

In order to provide these improvements, CMP proposes to add a half bus (supports a redundant secondary circuit), capacitor bank (provides energy storage), and gas breaker. These improvements are geared towards correcting power supply anomalies that often occur in industrial and commercial areas that have significant fluctuations in electricity use, thus improving efficiency and reliability. Recently CMP obtained approval for site plan upgrades via an Administrative Authorization from the Planning Department. This work included relocating a secondary access driveway.

The supporting documents that are attached include:

- General Building Permit Application Form;
- Certificate of Design, Signed and Sealed;
- General arrangement plan of the existing and proposed electrical components;
- Cross sections of component additions;
- General foundation plan; and
- Foundation details for each type of foundation (bus, breaker, capacitor bank, and gate).

All plans were prepared by SGC engineering, LLC, except for the bus foundation which replicates the existing foundations.

The application fee, \$1,210 is being sent via Federal Express. Thank you for your assistance with the review of this application. Please contact me at 620-3844 with any questions or comments and I will provide you with any additional information needed.
