As the lead design engineer for the Sheridan Corporation, I include our design/build general building permit application and related plan files for the small addition and fit up of office space for the Safelite Auto Glass tenancy at 421 Warren Avenue. Other than the new 20' x 90' truck dock addition, the fit up will be within the new, but presently vacant pre-engineered steel building at the above location. This building and site is presently owned by Mr. Peter Holmes. It was permitted and site amended by the City Planning Board this March for the new addition. That application was filed under Project ID #2014-016.

As Sheridan Corporation is a Design/Build Company, we do not yet have our subcontractors plans for mechanical, electrical or sprinkler system in hand today. We intend to file them over the next 2 weeks to complete our permit package.
