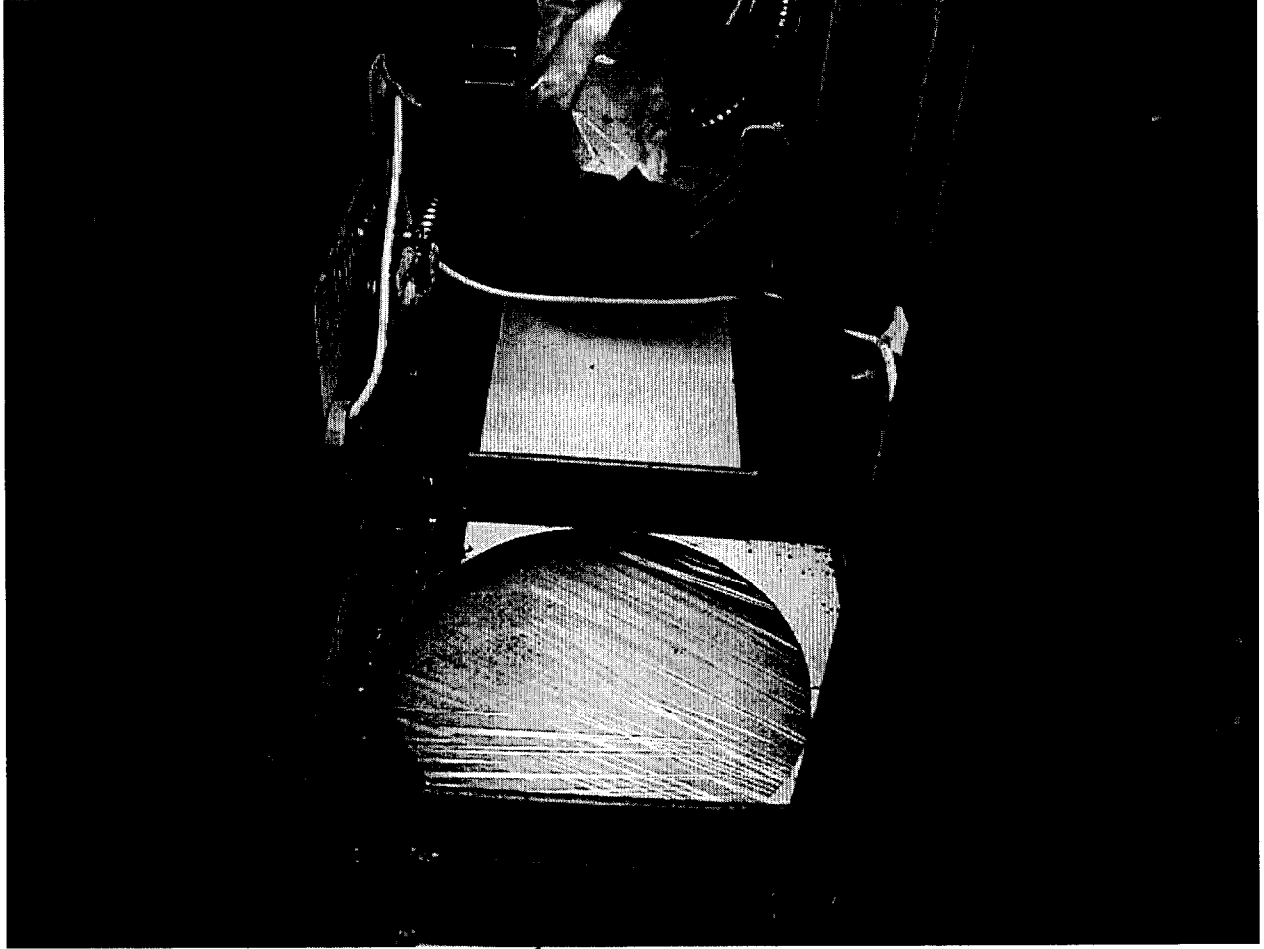

Here is the mounting detail for message sign being added to the existing 6" diameter steel post. Each face of the double sided message is bolted to a common steel angle frame. The steel angle frame will be welded to the post. Power will be supplied to the sign through the pole from the existing power feed. the picture shows a view from the top of the frame between the two message sign cabinets.
