This is a Notice of Violation pursuant to Section 22.03 of the Code. All referenced violations shall be corrected within **10 days** of the date of this notice. A re-inspection will occur on **08/31/2015**, at which time compliance will be required. Failure to comply will result in this office referring the matter to the City of Portland Corporation Counsel for legal action and possible civil penalties, as provided for in Section 1-15 of the Code and in Title 30-A M.R.S.A. Section 4452. This is an appealable decision pursuant to Section 12.80 of the Municipal Code.

**Violation: PREMISES TO BE KEPT FREE FROM RODENT HARBORAGE**

The owner of a two (2) or more family residential building and the owner or occupant of a single family residential building shall maintain the building and the lot on which the building is located free from any accumulation of any putrid substance, garbage, rubbish, old lumber, debris or rubble, except in watertight covered containers.

**Notes:** *Black trash bags and other bags filled with yard waste and debris will need to be removed by 8/31/15 or a \$150 re-inspection fee will be assessed to the property*

**Comments:** Violations exist of trash bags (black) and yard waste bags.
