**Meeting Minutes for Public Information Meeting  
April 30, 2014 6:00 pm**

Project: 421 Warren Avenue Site Development  
Applicant: PH Warren Avenue LLC  
Location: Riverton School, Portland, Maine  
Attendees: See attached list

The group convened at around 6:00 pm at which time Peter Holmes and Steve Bushey provided an overview of the proposed project to be located at 421 Warren Avenue. The project description included the building scope and proposed uses. It was explained that the project will be similar in nature to the property at 429 Warren Avenue, which is also owned by Mr. Holmes. The following are questions and comments from the group:

1. Will there be an access from Iffley Street or Lane Avenue? Mr. Bushey explained that the site will only be accessed from Warren Avenue and that overall Mr. Holmes is proposing to develop about 3 acres of the 48 acre parcel that he owns.
2. Mr. Holmes provided a long explanation about his goals for selling 40-43 acres of the parcel to the City of Portland. His development goals are to only complete this one project and to transfer the remaining land to the City.
3. The group discussed the Capasic Brook Watershed Plan prepared by the City and we discussed the role of the property within the scope of the watershed Master Plan. The attendees all generally expressed large desire to have the land placed into conservation by the City so as to prevent possible future development.
4. Mr. Bushey encouraged the attendees to contact their district City Councilor regarding the proposed land transfer.
5. Mr. Bushey explained the City review process and stated that the attendees are welcome to attend the Public Hearing for the project, at which time an approval will be sought.
6. The meeting lasted about 1 hour.
