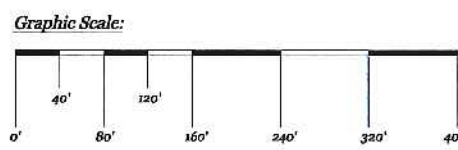
- 9. Locus Parcel is shown as City of Portland Assessor's Map 296, Block A, Lot 6, 301-J-10, 302-A-1, 303-A-8-10, 304-B-28, and 305-D-1, and is listed as 411-423 Warren Avenue.
10. Area of Locus Parcel is 418,393 square feet (9.60 acres).
11. The apparent right of way lines depicted on this plan are based on the Plan References listed herein and monumentation found in the field, and City of Portland Engineering Street Notes.
12. The Locus Parcel does not scale in a Special Flood Hazard Area per FEMA Flood Insurance Rate Map Community-Panel Number 230031 0006C, index dated December 8, 1998. The parcel scales in Zone X.
13. All building corner offsets to boundary lines are from cornerboards and not building foundation, unless noted.
14. Call 1-888-DIGSAFE at least three business days before performing ANY excavation.
15. Per City of Portland Records Vol. 2, Page 30 and Cumberland County Commissioners Records Vol. 16, Page 265, Warren Avenue was laid out January 5, 1892 as 4 roads (66 feet) wide. Per City of Portland Records Vol. 2, Page 203 and City of Deering Records Vol. 1, Page 324, the County Road running from Morrill's Corner to Westbrook was named "Warren Avenue" by Order of the City Council, passed November 27, 1893.
16. Vertical Datum is NGVD29. Benchmark established with GPS Static observations taken on October 28, 2013.
17. See CCRD Book 6161, Page 98, dated April 28, 1983, from Goodwill Of Maine, Inc. to Guy Gannett Broadcasting Services, for "the right to enter a certain strip of land being twenty (20) feet in width for the purpose of the passage of vehicles and pedestrians to be used only in connection with the maintenance and repair of the Grantee's antenna". (Also See Plan Reference 6)

Sebago Technics' plan for John Vance (Plan Reference 7) which appears to have held the above mentioned Jordan plans. Plan Reference 10 held monumentation which appears to mark the location of Saville Street on the southern sideline of Warren Avenue. This office did not hold Plan Reference 10. This office recommends a boundary line agreement or consulting an attorney for boundary lines along the eastern line of Holmes and the Proposed Lot, along land of Vance and Bennett, to the northeast corner of Bennett.
20. No record easement found for this drain pipe.
