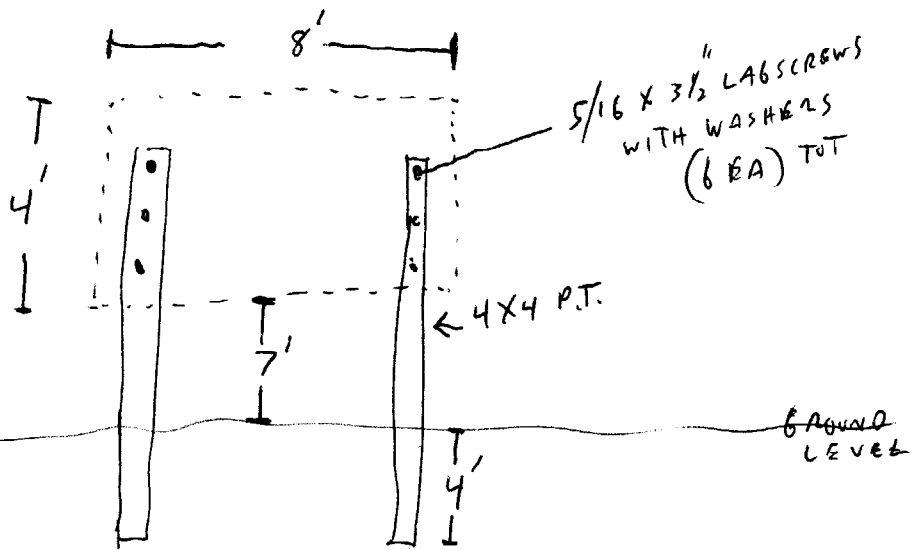

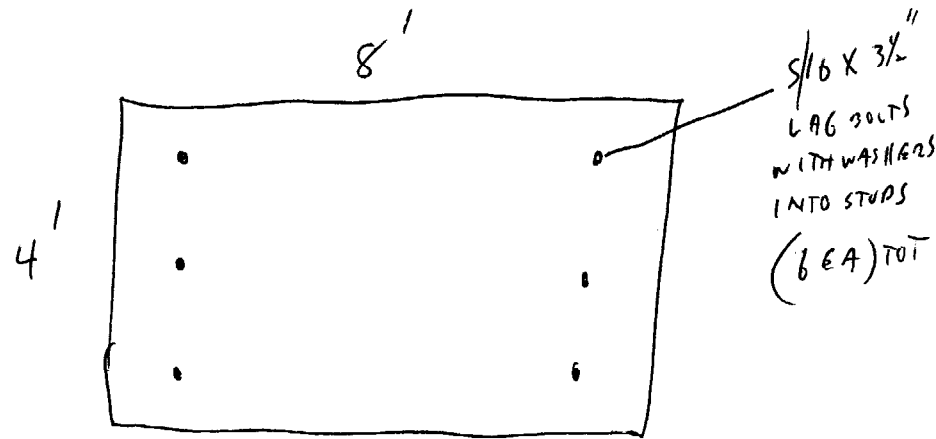

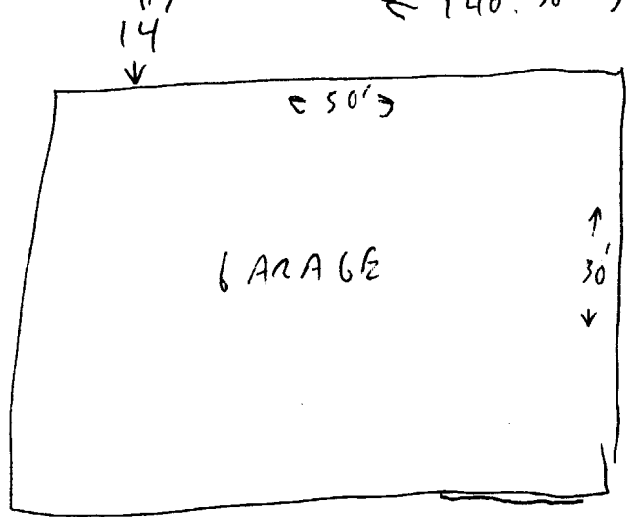

SIGN #1 STRUCTURE

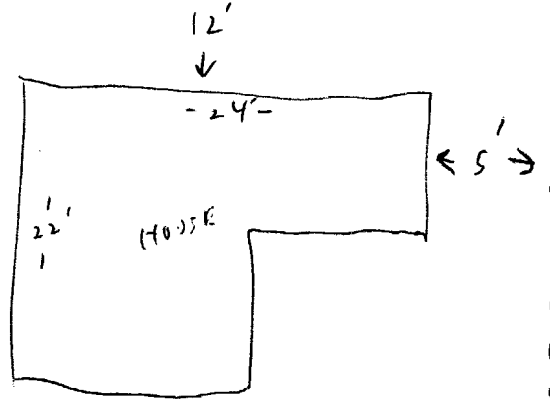


SIGN #2 STRUCTURE
