Jean the application itself is still not complete. WE have no way of knowing which Chart/Block/Lot this application should be attached to, because the application is missing the owner information (which is a requirement.) Also, because several e-mails have been sent, with different subject lines on the e-mails, its difficult to pinpoint what was said and when.

What is needed now, is a completed application with the owner info on it. There are 13 different accounts in our system with the CBL you provided. Having the owner info would've expedited this. Unfortunately, this cannot be entered until a complete application is provided. A change of use cannot be expedited. Because there is no construction, it should go quicker, but it still has to go through review. I apologize for any inconvenience but we can't enter a permit until it is complete.
