

QUITCLAIM DEED WITHOUT COVENANT
Statutory Short Form

KNOW ALL PERSONS BY THESE PRESENTS, that Gary S. Bedrosian, Trustee of the Gary S. Bedrosian Revocable Trust U/T/A dated November 22, 2005 with a mailing address of 30 Alexis Lane, Hampton Falls, New Hampshire 03844, for consideration paid, grants to Diversified Properties, Inc., a Maine Corporation with a mailing address of P.O. Box 10127 Portland, Maine 04104, a certain lot or parcel of land, with any buildings thereon, situated on or near Castine Avenue, Portland, County of Cumberland and State of Maine, as more fully described as follows:

Beginning at a point on the southerly sideline of Castine Avenue; said point being located S 59° 02' 58" W a distance of One Hundred Twelve and 25/100 (112.25) feet from the intersection of the southeasterly sideline of Castine Avenue and the southwesterly sideline of Forest Avenue; said point also being located at the northerly corner of Lot 131 as shown on a plan entitled "Deering Terrace owned by J.W. Wilbur Co. Inc." made by Ernest W. Branch dated April 20, 1915 and recorded in Plan Book 12, Page 6 and at the northerly corner of land now or formerly of Gary S. Bedrosian, Trustee of the Gary S. Bedrosian Revocable Trust U/T/A and Andrea D. Knight, Trustee of the Andrea D. Knight Revocable Trust U/T/A as described in a deed recorded in the Cumberland County Registry of Deeds in Book 23492, Page 76, and as described in a deed from Clare B. Knight to Andrea D. Knight recorded in the Cumberland County Registry of Deeds in Book 15342, Page 310. Thence:

- 1) S 59° 02' 58" W by said Castine Avenue distance of Sixteen and 39/100 (16.39) feet to a point shown as the northerly corner of "Trust Lot A" on a plan entitled "Plan of Boundary Survey Forest Ave., Castine Ave. and Brandon St. made for W&C LLC," by Titcomb Associates dated September 14, 2006, and recorded in the Cumberland County Registry of Deeds in Book 206, Page 645.
- 2) S 30° 57' 02" E partially by said Trust Lot A a distance of One Hundred and 00/100 (100.00) feet to a point.
- 3) N 59° 02' 58" E a distance of Sixty-Five and 00/100 (65.00) feet to a point.
- 4) N 30° 57' 02" W a distance of One Hundred and 00/100 (100.00) feet to a point on the southeasterly sideline of said Castine Avenue.
- 5) S 59° 02' 58" W by said Castine Avenue a distance of Forty-Eight and 61/100 (48.61) feet to the point of beginning.

Said parcel contains 6,500 square feet (0.15 acres), more or less.


