PLUMBING DEMOLITION NOTES:

1. REMOVE ALL EXISTING PLUMBING SYSTEMS WITHIN THESE AREAS INCLUDING FIXTURES, FLOOR DRAINS AND ALL ASSOCIATED SANITARY WASTE, VENT, WATER PIPING BACK TO MAIN. REFER TO PLUMBING FLOOR PLANS.

2. PLUMBING CONTRACTOR SHALL REMOVE ALL EXISTING WATER PIPING ENTIRELY FROM BUILDING, WITH THE EXCEPTION OF MAIN ENTERING WATER SERVICE AND ASSEMBLY. REFER TO PLUMBING FLOOR PLANS.

3. PLUMBING CONTRACTOR SHALL REMOVE ALL EXISTING COMPRESSED AIR PIPING, DROPS AND ASSOCIATED EQUIPMENT ENTIRELY FROM BUILDING.

4. PLUMBING CONTRACTOR SHALL DEEP ALL EXISTING PLUMBING SYSTEMS TO REMAIN CAPPED AND CLEAN FROM CONSTRUCTION DEBRIS.

5. EXISTING UNDERFLOOR SANITARY LINE AND EXTERIOR PUMP CHAMBER TO BE REMOVED, AND ABANDONED. CAP EXISTING SANITARY MAIN, REMOVE ALL CLEANOUTS VENTS, COORDINATE WITH GENERAL CONTRACTOR.

6. EXISTING 2 LB. ELEVATED GAS LINE AND METER ETC. SHALL BE REMOVED AND ALL NEW .5 LB GAS SYSTEM TO BE INSTALLED. EXISTING JOHNSON AIR HEATING UNIT TO BE UTILIZED FOR TEMPORARY HEATING. INSPECT, SERVICE AND COORDINATE WITH GAS CO. AND HVAC CONTRACTOR. TOTALLY REMOVE ALL GAS PIPING, VENTING ETC. AFTER NEW HEATING SYSTEMS HAVE BEEN INSTALLED.


