

GENERAL NOTES

- I. CONDUCT FIELD SURVEY OF EXISTING CONDITIONS PRIOR TO SUBMISSION OF BID AND START OF WORK. NO ADDITIONAL PAYMENTS WILL BE MADE ON CLAIMS THAT ARISE FROM LACK OF KNOWLEDGE OF EXISTING CONDITIONS.
- 2. COORDINATE SCHEDULE OF WORK REQUIRED IN OCCUPIED AND OPERATING AREAS WITH OWNER PRIOR TO STARTING SUCH WORK.
- 3. SCHEDULE UTILITY SERVICE SHUTDOWNS REQUIRED FOR NEW CONSTRUCTION WITH OWNER AND GENERAL TRADES PRIOR TO SHUTTING DOWN SYSTEMS. GIVE ONE WEEK ADVANCE NOTICE.
- 4. REMOVE AND REPLACE EXISTING CEILINGS TO ACCOMMODATE NEW WORK. REPLACE DAMAGED CEILING TILES WITH NEW.
- 5. CUT FLOOR, WALL, AND CEILING CONSTRUCTION FOR PENETRATIONS TO ACCOMMODATE NEW WORK. COORDINATE WITH GENERAL TRADES. PATCH CONSTRUCTION TO MATCH, OR TO SATISFACTION OF ARCHITECT AND OWNER.
- 6. ALL WORK TO BE COMPLETED IN ACCORDANCE WITH THE LOCAL BUILDING CODE AND AUTHORITY HAVING JURISDICTION.

- 2 EXISTING WATER METER AND BACKFLOW PREVENTER, TO REMAIN.
- (3) EXISTING FIXTURE TO REMAIN.
- (4) EXISTING FLOOR DRAIN TO REMAIN.
- 5 REMOVE EXISTING WATER HEATER AND ASSOCIATED DOMESTIC WATER PIPING. DISCONNECT GAS AND REMOVE BACK TO MAIN AND CAP.
- REMOVE EXISTING VENT THROUGH ROOF. PATCH TO MATCH EXISTING.
- (7) REMOVE EXISTING FIXTURE.
- (8) REMOVE EXISTING FLOOR DRAIN.
- <9> REMOVE EXISTING CLEANOUT.
- (IO) REMOVE EXISTING CONDENSATE DRAIN PIPING.
- (II) REMOVE EXISTING FIXTURE DRAIN PIPING.
- (12) REMOVE EXISTING SANITARY SEWER PIPING TO POINT INDICATED AND CAP. ABANDON IN PLACE.
- (3) REMOVE EXISTING SANITARY SEWER PIPING TO POINT INDICATED, PREPARE PIPE END FOR NEW
- (4) REMOVE EXISTING DOMESTIC WATER PIPING.
- (15) REMOVE EXISTING DOMESTIC WATER PIPING TO POINT INDICATED, PREPARE PIPE ENDS FOR NEW CONNECTION.
